

**ORDER PASSED BELOW EXH.1.**

1. The applicants have claimed heirship certificate under Section 2 of Bombay Regulation Act, on the ground of legal heirs of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan, he was died on 28.12.2020 at Kapurwadi, Tal. Dist. Ahmednagar.

2. It is the contention of the applicants that, deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan, he was died on 28.12.2020 leaving behind applicants. Applicant No.1 and 2 are sons, applicant No.3 is daughter and applicant No.4 is wife of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan. Except the above said applicants there are no legal heirs left by deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan. The applicants are in need legal heirship certificate for mutation of their names to the Survey No.160 situated at Akola, Tal. Pathardi, Dist. Ahmednagar which were standing in the name of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan.

3. In pursuance to the application, paper publication in daily newspaper "Punyanagari" of dated 29.11.2025 at Exh. 11 was issued and thereby objections were called. The public notice was also issued but, none was appeared and objected the claim of applicants as heirs of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan.

4. Applicant No. 1 Munna adduced his evidence by way of affidavit Exh.13. In support of their claim, they relied on copy death



certificate of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan, village form-7 of Gat No.160 situated at Akola, Tal. Pathardi, Aadhar Cards of applicants. The learned counsel of the applicants closed evidence by filing pursis Exh.14. The evidence of applicants remained unchallenged as none appeared to oppose. It is established by original copy of death certificate of Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan that he has been died on 28.12.2020 from the written documents, it is established that the applicants are the legal heirs of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan. Therefore, I inclined formally to hold that the applicants are the legal heirs of deceased Salim @ Nanhubhai @ Salimbhai Dagadu @ Dagadubhai Pathan. Though applicants mentioned alias names of the deceased. But in absence of documents it is property issued heirship certificate in the name as mentioned in death certificate. Hence, I proceed to pass following order.

ORDER

- 1] Application is allowed.
- 2] Applicant No.1. Munna Salim Pathan, No.2 Mansur Salim Pathan, No.3 Aaysha Salim Pathan and No.4. Laila Salim Pathan are hereby formally recognized to be the legal heirs of deceased Salimbhai Dagadu Pathan for mutation of their names to Gat No.160 situated at Akola, Tal. Pathardi.
- 3] Accordingly, issue legal heirship certificate to the applicants on paying requisite court fee, with note as per para No.312 and 313 of the Civil Manual.
