02] Bhimrao Sudam Sathe,

Age:- 59 Years, Occ.:- Labour,

R/o. Dhalewadi, Pargaon Tal. Patoda, Dist. Beed.

03] Ruman Alim Kureshi (Khureshi),

Age:- 18 Years, Occ.:- Labour,

R/o. Dhalewadi, Pargaon Tal. Patoda, Dist. Beed.

...Accused.

As follows :

Firstly, you accused, in furtherance of your common intention, on 16/10/2024, at about 10.30 am, in front of Dhamangaon Bus Stop, at Devdaithan-Dhamangaon road, Tal. Jamkhed, Dist. Ahmednagar, transport or offer for transport or cause to be transported cows and calf within the State for the purpose of its slaughter in contravention of the provisions of The Maharashtra Animal Preservation Act, 1976 Act or with the knowledge that it will be or is likely to be, so slaughtered and that you have thereby committed an offence punishable under Section **5(A)** of The Maharashtra Animal Preservation Act, 1976 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023.

Secondly, you accused, in furtherance of your common intention, on the aforesaid date, time and place, purchase, sell or otherwise dispose of or offer to purchase, sell or otherwise dispose of cows and calf for slaughter or knowing or having reason to believe that such cows and calf shall be slaughtered and that you have thereby

committed an offence punishable under Section **5(B)** of The Maharashtra Animal Preservation Act, 1976 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023.

Thirdly, that you accused, in furtherance of your common intention, on the aforesaid date, time and place, transported the cows and a calf for the purpose of their slaughter, and while being a person having the care and charge of the said animals, failed to take all reasonable measures to ensure their well-being and failed to prevent the infliction of unnecessary pain and suffering upon the said animals and thereby committed an offence punishable under Section **3** of the Prevention of Cruelty to Animals Act, 1960 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023

Lastly, that you accused, in furtherance of your common intention, on the aforesaid date, time and place, conveys or carries, whether in or upon any vehicle, two cows and one calf in such a manner or position as to subject it to unnecessary pain or suffering and thereby committed an offence punishable under Section **11** of the Prevention of Cruelty to Animals Act, 1960 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023.

Above offences are within my cognizance and I hereby direct that you be tried before me on the aforesaid charge.
