I, A. B. Phand, Judicial Magistrate First Class, Court No.02, Jamkhed hereby charge you :-

01] Asaram Tulshiram Savant,

Age:- 40 Years, Occ.:- Agriculture,

02] Vaibhav Asaram Savant,

Age: 21 Years, Occ.:- Agriculture,

Both R/o. Vaki, Tal. Jamkhed, Dist. Ahmednagar.

...Accused.

As follows :

Firstly, on 14/07/2021 at about 19.30, in Vaki village, at Vaki-Loni road, Near the school of Shelke Guruji, Tal. Jamkhed, Dist. Ahmednagar, you accused nos. 01 and 02, in furtherance of your common intention, voluntarily caused hurt to the informant and his grandson by means of stone and wooden stick which used as a weapon of offence are likely to cause death and that you have thereby committed an offence punishable under Section **324 read with Section 34** of the Indian Penal Code.

Secondly, on the aforesaid date, time and place, you accused nos. 01 and 02, in furtherance of your common intention, voluntarily caused hurt to the informant and his grandson and thereby committed an offence punishable under Section **323 read with 34** of the Indian Penal Code.

Thirdly, on the aforesaid date, time and place, you accused nos. 01 and 02, in furtherance of your common intention, intentionally

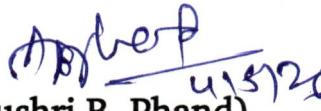

insulted to the informant and his grandson by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break the public peace and thereby committed an offence punishable under Section **504 read with Section 34** of the Indian Penal Code.

Lastly, on the aforesaid date, time and place, you accused nos. 01 and 02, in furtherance of your common intention, committed criminal intimidation by threatening to the informant with intent to cause alarm to them, and that you have thereby committed an offence punishable under Section **506 read with Section 34** of the Indian Penal Code, 1860.

Above offence are within my cognizance and I hereby direct that you be tried before me on the aforesaid charge.

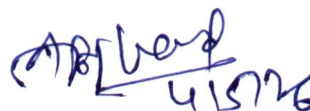
