IN THE COURT OF JUDICIAL MAGISTRATE, FIRST CLASS, KARJAT

: CHARGE :

I, R. B. Raut, Judicial Magistrate, First Class, Karjat (Court No.2), do hereby charge you :-

1. Baliram Parmeshwar Jadhav

Age : 30 Years, Occ. : Service,

2. Chandrakala Parmeshwar Jadhav

Age : 53 Years, Occ. : Household work,

3. Parmeshwar Murlidhar Jadhav

Age : 65 Years, Occ. : Agriculturist,

Accused No. 1 to 3 R/o. Takalsing, Tal. Ashti, Dist. Beed.

4. Sunita Sharad Raut

Age : 28 Years, Occ. : Household work,

5. Sharad Prabhakar Raut

Age : 39 Years, Occ. : Service,

Accused No. 4 and 5 R/o. Walvad, Tal. Karjat, Dist. Ahmednagar.

That, from 10/05/2023 to 15/09/2023 at the paternal and maternal house of parental and maternal of the complainant, you the accused no.1 Baliram Parmeshwar Jadhav being the husband of the informant and accused No.2 to 5 being her husband's relative, in furtherance of their common intention, subjected to the informant physical and mental cruelty for illegal demand of Rs. 5,00,000/- and that you have thereby committed an offence punishable under Section 498 A read with 34 of the Indian Penal Code and within my cognizance.

2. Secondly, during the same time frame, you all accused persons, in furtherance of their common intention, voluntarily caused simple hurt to the informant Anuja by kicks and fist blows and thereby you have committed an offence punishable under Section 323 read with 34 of the Indian Penal Code and within my cognizance.

3. Thirdly, during the same time frame, you all accused persons in furtherance of their common intention, committed criminal intimidation by insulted the informant Anuja and thereby gave provocation to her intending or knowing it to be likely that such provocation will cause her to break the public peace, thereby committed an offence punishable under Section 504 read with 34 of the Indian Penal Code and within my cognizance.

4. Lastly, during the same time frame, you all accused persons in furtherance of their common intention, committed criminal intimidation by threatening the informant Anuja with intent to cause alarm to her and thereby committed an offence punishable under Section 506 read with 34 of the Indian Penal Code and within my cognizance.

And I hereby directed that you be tried by this court on the said charge.
