: CHARGE :

I, R. B. Raut, Judicial Magistrate First Class, Karjat, do hereby charge you :-

1. **Ranjana Dashrath Tambe**
Age : 55 Years, Occu. : Agriculturist,
2. **Sonali Sanket Tambe**
Age : 27 Years, Occu. : Agriculturist,
3. **Dashrath Sopan Tambe**
Age : 64 Years, Occu. : Agriculturist,
4. **Somnath Dashrath Tambe**
Age : 28 Years, Occu. : Agriculturist,
5. **Sanket Dashrath Tambe**
Age : 30 Years, Occu. : Agriculturist,
All R/o. Tambe Vasti, Rashin
Tal. Karjat, Dist. Ahmednagar.

That, on 26/05/2024 at about 06.15 pm. At maternal house of informant, Tambe Vasti, Rashin, Tal. Karjat, you all accused persons were a member of an unlawful assembly and thereby you all committed an offence punishable under **Section 143 of the Indian Penal Code** and within my cognizance.

2. Secondly, on the same date, time and place you all accused persons were a member of an unlawful assembly and in prosecution of the common object of such assembly used force or violence on the informant and witness and thereby you have committed an offence punishable under **Section 147 r/w. 149 of the Indian Penal Code** and within my cognizance.

3. Thirdly, on the same date, time and place, you all accused

persons were a member of an unlawful assembly and in prosecution of the common object of such assembly voluntarily caused hurt to the informant by means of cable on his back, which is used as weapon of offence is likely to cause death and that you have thereby committed an offence punishable under **Section 324 r/w. 149 of the Indian Penal Code** and within my cognizance.

4. Fourthly, on the same date, time and place, you all accused persons were a member of an unlawful assembly and in prosecution of the common object of such assembly voluntarily caused simple hurt to the wife of informant and daughter of informant by means of kicks and fist-blows and informant wife's head hit on the ground and thereby you have committed an offence punishable under **Section 323 r/w. 149 of the Indian Penal Code** and within my cognizance.

5. Fifthly, on the same date, time and place, you all accused persons were a member of an unlawful assembly and in prosecution of the common object committed criminal intimidation by insulted the informant and witnesses and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break the public peace and thereby committed an offence punishable under **Section 504 r/w. 149 of the Indian Penal Code** and within my cognizance.

6. Lastly, on the same date, time and place you all accused persons were a member of an unlawful assembly and in prosecution of the common object committed criminal intimidation by threatening the informant and witness of death with intent to cause alarm to them and thereby committed an offence punishable under **Section 506 r/w. 149 of the Indian Penal Code** and within my cognizance.

And I hereby directed that you be tried by this court on the said charge.
