**EXAMINATION IN CHIEF**

( by Ld. APP Shri S. A. Patekar )

I am educated upto M.B.B.S., D.G.O. I was working as medical officer from 2015 till 2022 at Parner rural hospital. Dnyaneshwar Janardan Borude, aged 22 years, R/o.Viroli, Tal.Parner had come to hospital on 21.12.2020 at 11.00 a.m. I do not have his case paper number. He was having identification mark as black mole on his back. He had come with police yadi to the hospital. He came with a history of assault on him on 20.12.2020 at 6 p.m.

Upon examination, I found following injuries;

1. Incised wound on head on occipital region, size 3 cm x 4 mm. It was caused by sharp object. Age of injury was less than 24 hours. It was simple in nature.
2. Incised wound on chin, size 1.5 cm x 3 mm. It was caused by

sharp object. Age of injury was less than 24 hours. It was simple in nature.

I treated the patient on OPD basis. I did not refer him to any hospital. Accordingly, I prepared MLC of Dnyaneshwar Borude. Now, MLC certificate of Dnyaneshwar Borude shown to me. It was issued by me. It bears my signature and contents of it are true and correct. It is marked as **Exh.41**. The injuries mentioned by me might be caused by use of sharp object. Those injuries might be caused if stone is used for assaulting a person.

### **CROSS - EXAMINATION**

( By accused Ld. Adv. M.B. Gaikwad)

I am working as a medical officer since the year 2009.

Que. What is the procedure when a patient comes before you?

Ans: Firstly, history of patient is taken. Then he is examined, if any injury is found, then that injury is recorded and accordingly treatment is to be given to the patient.

It is true to say that whenever a patient comes before me, his case paper is to be prepared. It is not true to say that I have not prepared case paper of Dnyaneshwar Borude. It is true to say that MLC register is maintained at rural hospital.

Que. MLC register is not available with you today?

Ans: It is kept at rural hospital, Parner.

It is true to say that MLC number is entered on the medical certificate. I cannot definitely say whether MLC number is mentioned on the medical certificate or not. It is true to say that I had not mentioned what medicines were prescribed by me on the MLC. It is not true to say that MLC is prepared according to the

MLC register. It is not true to say that the injuries mentioned by me might be sustained by the informant if the informant has slipped and fallen down or if the informant has fallen from the vehicle. It is not true to say that I am deposing falsely at the instance of police.

Cross examination is over.
