ORDER BELOW EX.1.

[Passed on 07.03.2026]

1. This is an application under Section 482 of the Bhartiya Nagarik Suraksha Sanhita, 2023 for grant of pre-arrest bail.
2. The applicant/accused apprehend his arrest in crime No. 236/2026 registered with P.S. Balapur, Tq. Balapur, Dist. Akola for the offences punishable under Sections – 109, 118(2), 352, 3(5) of Bhartiya Nyaya Sanhita, 2023.
3. It is contended by the applicant that he has no

concerned with alleged crime. He is permanent resident of village Wadegaon having movable and immovable property. He is a member of Grampanchayat Wadegaon. He is reputed person. Main accused were arrested and they are behind bar. The custody of the applicant is not required for the interrogation. Nothing is to be seized from his possession. He is ready to abide each and every conditions imposed by this Court. He is ready to cooperate with the police machinery. Therefore, He has prayed for pre-arrest bail.

4. In response to the notice, the prosecution/State has filed reply at Ex.5. It is submitted that the offence is serious. The injured has sustained grievous injury. The applicant is absconding. There is possibility of tampering prosecution evidence and threatening the witnesses. The custody of the applicant is necessary for the investigation. The applicant is having criminal antecedent. Hence, prosecution prayed to reject the application.
5. Heard Ld. Advocate Shri Naurangabade for the applicant and Ld. APP Shri Fundkar for the State. I have also gone through the investigating papers made available by the prosecution.
6. As per FIR, there was quarrel between the informant and accused on the reason of amount.

Accused Sahil abused Arif Shaikh and pushed him. The informant went to save him accused abused him. Thereafter father of accused Sahil namely Babu Jamadar came there. He caught hold Sk. Harif and accused Sahil gave blow by knife in the stomach and caused grievous injuries.

7. On perusal of case papers and FIR, it reveals that nothing is to be recovered from the applicant/accused. As per reply filed by the Investigating Officer, the custodial interrogation of the applicants is not required. The offence alleged against the applicants is not punishable with death sentence. There are only allegations against the applicant that he caught hold the injured. Therefore, considering facts, I am of the opinion that the applicant/accused has made out the case for grant of pre-arrest bail. With this I proceed to pass the following order:-

ORDER

- 1] Application is hereby allowed.
- 2] In the event of arrest of applicant- **Shaikh Salim Shaikh Raullah** be released on bail in Crime No. 236/2026 registered with P.S. Balapur, Tq. Balapur, Dist. Akola, for the offences punishable under Sections – 109, 118(2), 352, 3(5) of BNS on furnishing P.B. & S.B. of **Rs.20,000/-** (Rs. Twenty Thousand only) on following terms:-

3] Applicant shall produce his permanent residential address-proof before the Investigating Officer and shall intimate change in his address, if any, in future to I.O. as well as to the Court.

4] He shall attend the concerned police station on every Sunday in between 11.00 am to 1.00 pm till filing of charge-sheet and co-operate in further investigation.

5] Applicant shall not directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the accusation against him so as to dissuade him/her from disclosing such facts to the Court or to any police officer.
