

ORDER BELOW EXHIBIT-18

(Date:-20.08.2025)

1] It is an application under section 503 of Bharatiya Nagarik Suraksha Sanhita, 2023 for release of the vehicle seized in this case bearing No. MH-30-AP-2655 of Hero Honda CB Shahin made, Chasis No. MH4JC36MLE7146605, Engine No. JC36E73776268. It is contended by the applicant that in the aforesaid crime, aforesaid vehicle is seized by the police. Now, the investigation is over, charge-sheet is filed. Further detention of the vehicle is no more require for the purpose of the investigation. Applicant undertakes to produce the vehicle as and when directed by the Court. It is therefore requested till final disposal of the matter, the vehicle be released. Application is supported by an affidavit and documents.

2] The prosecution resisted the application by filing say at Exh. 20 contending that if the motorcycle is released, there is possibility that it may be again used for committing the crime. Therefore, the application be rejected.

3] Heard both sides. The purpose for which the motorcycle is seized, is already over. Therefore, further detention of the vehicle in Police Station is no more required. Applicant is ready to undertake to produce the motorcycle as and when required by the Court. In view of this, it appears to me that application deserves to be allowed. Hence, the following order-

ORDER

- i] The application is allowed.
- ii] The officer in-charge of Police Station Civil Lines, Akola is hereby directed to release the seized motorcycle bearing No. MH-30-AP-2655 of Hero Honda CB Shahin made, Chasis No. MH4JC36MLE7146605, Engine No. JC36E73776268 in crime No. 18/2025, in favour of the applicant Dipali Ravindra Shende on her executing Supratnama on indemnity bond of Rs.50,000/-.
- iii] The applicant shall produce the said vehicle as and when directed by this Court.
- iv] The applicant shall not sell, alter, alienate or change the seized vehicle in question, in any manner, till the decision of the trial.
- v] The applicant shall keep the vehicle in good condition.
- vi] The Investigating Officer shall obtain photographs of present day condition of the vehicle before handing it over to the applicant at the costs of the applicant and submit those photographs in the Court for the purpose of record.
- vii] Inform the concerned Investigating Officer, accordingly.
