ORDER BELOW EX.01.
[Passed on 25.06.2026]

1. This is an application for relaxation of condition imposed vide bail order dated 15.04.2024 passed in Criminal Application No.181/2024 in connection with Crime No.166/2024 registered with Dabki Road Police Station, Akola, Tq. Dist. Akola.
2. The accused/applicant is charged for the offences punishable under Sections-306, 504, 506 of IPC. As per order dtd.15.04.2024 the applicant is granted anticipatory bail with the direction to surrender his passport before the Investigating Officer.
3. The documents filed by the applicant/accused further shows that as per directions given in bail order dtd. 15.04.2024, he has surrendered his passport to the Investigating Officer.
4. Prosecution filed reply at Exh. 06. It is submitted that at the time of passing of order on anticipatory bail application, the condition was imposed by the Court for surrendering the passport to the Investigating Officer. The charge-sheet is yet to be filed. The prosecution has applied

for permission to file charge-sheet before Hon'ble High Court. It is further submitted that there is possibility that the applicant may remain absent at the time of filing of charge-sheet. On these grounds, the prosecution raised objection for allowing the application.

5. Heard both the sides. Perused order and documents filed by the applicant.
6. As per contentions of the applicant, the offence came to be registered in Police Station Dabki Road, Akola vide Crime No. 166/2024 for the offences as mentioned above. The applicant has surrendered his passport to the Investigating Officer. The applicant has produced the text message issued from the Passport Authority for renewal of the passport. The date of expiry of passport is 19.07.2026. The applicant is ready to re-surrender the passport after renewal.
7. Considering the circumstances, I come to conclusion that it is just and proper to allow the applicant to initiate the proceeding of renewal of passport. Hence, the order as follows :-

ORDER

- 1] Application is allowed.
- 2] The P.S.O., Dabki Road Police Station is hereby directed to return the original passport bearing No. N-9355644 to the applicant, so as to enable him to get it renewed.

- 3] The applicant is directed to surrender the passport after renewal within a period of three months from the date of order.
- 4] Application is disposed off accordingly.
