CHARGE

I, A. A. Mali, Judicial Magistrate First Class, Court No. 2, Akot Dist. Akola hereby charge you accused,

- 1) Nikhik S/o Himmatao Kahar,
aged about 32 years, Occu. Driver.
R/o. Akola Road, Akot, Tq. Akot,
Dist. Akola.
- 2) Harsh S/o Ram Kahar,
aged about 19 years, Occu. Labour.
R/o. Near Bhulja Bhulai Temple,
Akot, Tq. Akot, Dist. Akola.

as follows :

That, on 29.07.2023 at about 11:00 PM near the on Takpura road, Akot, Tq. Akot Dist. Akola, you accused in furtherance of your common intention voluntarily caused hurt to the informant's father namely Subhash Gaur by means of iron rod on his head and thereby you committed an offence punishable U/s. 324 r/w 34 of IPC within the cognizance of this Court.

Secondly, on the same date, time and place you accused in furtherance of your common intention voluntarily caused hurt to the informant namely Kajal Nikhil Kahar and thereby you committed an offence punishable U/s. 323 r/w 34 of IPC within the cognizance of this Court.

Thirdly, on the same date, time and place you accused in

furtherance of your common intention intentionally insulted informant, informant's sister namely Vaishnavi, brother namely Roshan and father namely Subhash by abusing them and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you committed an offence punishable U/s. 504 r/w 34 of IPC within the cognizance of this Court.

Lastly, on the same date, time and place you accused in furtherance of your common intention criminally intimidated the informant that you would kidnap her sister Vaishnavi and thereby you committed an offence punishable U/s. 506 r/w 34 of IPC within the cognizance of this Court.

And I hereby direct that, you be tried by this Court for the said charge.
