Examination-In-Chief By App Smt. Fauzia T. A. Saddique

1. I have completed my MBBS from GMC, Nagpur in 2018 and M.S. Ortho. From NKP Salve College, Nagpur in 2023. I was attached with Wadegaon PHC in 2018 and 2019 as a bonded medical officer. On 1810/2018 I was on my duty at PHC, Wadegaon, one patient namely Gangadhar Masane was brought by police to me for examination and medical treatment. There is history of assault by someone.

2. On being examined, I found following injuries on the person of the patient:

- I. Lacerated wound over left ear,
- II. Lacerated wound over head.

The said injuries were simple in nature. I extended primary treatment to the patient and referred him to GMC, Akola for further treatment. Now, I am shown the said referring letter which bears my signature. The contents in said letter are true and correct. The said letter is marked at **Exh. 39**.

3. I cannot tell the probable age of injury. On 13/11/2018 H.C. Balkrushna Ingle B.No.672 had brought one wooden stick for purpose of my opinion in respect of the injury as to whether it was caused with said stick along with letter. The said letter acknowledge by me. Now, I am shown the said letter which bears my signature as received. The contents of the said letter are true and correct. The said letter is marked at **Exh.40**. In pursuance of the said, I had given my opinion in respect

of the wooden stick brought to me. According to me, the injury mentioned over referral letter dated 18/10/2018 might be possible with the wooden stick produced before me. As such, I issue opinion letter. Now, I am shown the said opinion letter which bears my signature and contents of the said letter are true and correct. The said letter is marked at **Exh.41**.

4. I can identify the wooden stick brought to me for query. Now, one wooden stick is produced before the court with label bearing signature of panchas and accused. Now, this wooden stick is marked at **Article 1**. The injury nos.1 and 2 may be possible with Article 1.

Examination in chief is over.

Cross examination by Adv. Shri. S. T. Ingle:-

5. It is true to say that, the injury nos.I and II may be possible if the person fell upon the hard surface. It is true to say that, I had not any identification marked over the wooden stick brought to me by the police, so as to verify later. It is not true to say that, on 18/10/2018, I never examined the patient namely Gangadhar Masane and referred him to Akola for further medical treatment. It is not true to say that, at the instance of the police I issued referral letter at Exh. 39 and opinion letter at Exh. 41 to assist the police. It is not true to say that, I deposed falsely.
