Examination-In-Chief By App Smt. Fauzia T. A. Saddique:-

1. I have completed MBBS from Govt. Medical College, Miraj, Dist. Sangli in 2001. I was working with Balapur, Rural Hospital as a Medical Officer since 2003 to 2009 and thereafter, 2010 to 2019. Currently I am working with Rural Hospital, Balapur since 2024 to till date. On 25.10.2018, I was on duty at Rural Hospital, Balapur at about 1.40 p.m., P. C. Amol, B.No.2073 had brought to me one injured namely Pnachafulabai Kisan Wankhade, age 50 yrs., residing at Mandoli, Tq. Balpur for medical examination and treatment with requisition letter. Now, I am shown the said requisition letter which bears my signature as a received. The said letter is marked at **Exh. 36**. Accordingly, I personally examined injured person to which I found that, the patient is having case of diabetes and observed following injuries:-

1. Right fore arm abrasion, simple injury,
2. Left thumb injury, simple injury,
2. The said injuries was caused before one and half hour from the examination. The healing period of the said injuries were 7-10 days. This injuries were possible to be caused with blunt and hard object. Upon medical examination and extended medical treatment, I have issued injury certificate bearing my signature and seal. Now, I am shown the said injury certificate bears my signature and contents are true and correct. The said injury certificate is marked at **Exh.37**. The

said injuries can be possible with Article 1 sickle.

Examination in chief is over.

Accused no.1 and 2 are present. The advocate absent when called upon till 1 O'clock. The accused nos.1 and 2 declined cross-examination.
