Examination-In-Chief By App Smt. Fauzia T. A. Saddique

1. I have completed MBBS and Orthopedic from MINER, Medical college, Pune and YCM Hospital Pimpri Pune, in 2005 and 2007 respectively. I was running Srikrupa Hospital, Akola since year 2011 to till date. On 01.07.2018, when I was in my hospital, One patient namely Sukhram Telgote was brought to me for medical treatment by his relatives. While examination, the patient gave me history of assault to him by unknown person with blunt object. On being examined patient, I found following injuries:-

1. left side Tibia and Fibula fracture, grievous injury, the said injury may be possible with hard and blunt injury, duration – less than 24 hours,
2. Right sided Patella fracture, nature of injury was grievous, hit by blunt object and duration was less than 24 hours,
3. Right ear wound, nature of injury simple, hit by blunt object, and duration was less than 24 hours.

2. Upon examined, I admitted the patient in my hospital. Accordingly, on 04.07.2018, I had carried out surgery on left side Tibia. The patient came to be discharged on 07.07.2018. Accordingly, I issued discharge card of the said patient. Now, I am shown the said discharge card which bears my signature and contents are true and correct. The said discharge card is marked at **Exh.63**.

3. I received the letter from the Police Station, calling upon

me to issue injury certificate of patient namely Sukhram Telgote. Now, I am shown the said letter which bearing my signature as a received. The said letter mark at **Exh.64**. Pursuant to the said letter, I issued injury certificate of the patient namely Sukhram Telgote. Now, I am shown the said injury certificate which bears my signature the contents are true and correct. The said certificate is mark at **Exh.65**. Now, I am shown Article ३ Wooden दांडा. The injury No.1 to 3 might be possible with Article ३.

Examination in chief is over.

Cross examination by Adv. Shri. R. N. Wankhade:

5. I do not aware as to whether this patient had gone to any other hospital prior to my treatment. It is true to say that, the patient as well as his relatives did not informed me as to whether they had gone to any other hospital for treatment.

Q. Is it true to say that, considering age of the patient the bones gets brittle ?

Ans. I had not carried out any diagnose with respect to bones.

6. It is true to say that, if the person felled upon drainage line by sticking his leg, then these types of injuries may be possible.
