**ORDER**


(Passed on 14.03.2026)

1. The accused stands prosecuted for the offence punishable under section 285 of the BNS. The particulars of offence are read over and explained to the accused in vernacular. He pleaded guilty to the same and prayed for mercy.
2. The plea of accused and interrogation conducted by this Court with him shows that it is voluntarily made and hence, I accept the plea of accused being voluntarily made. Accused submitted that, this is his first offence of which now he is repenting upon and hence, considering his poor condition, lenient view be taken while passing sentence. Learned APP prayed for suitable order in view of the acceptance of guilt by the accused. Thus, considering facts and circumstances of the case and nature of the offence, I take the lenient view and proceed to pass the following order.
