**ORDER BELOW EXH.1**

(Passed on 07<sup>th</sup> April, 2026)

This is an application filed for grant of legal heirship certificate.

2) The applicants submit that the deceased **Abdul Subhan Abdul Razzak** died on **dtd. 27/08/2024** at Moulali Pura, Barshitakli, Tq. Barshitakli, Dist. Akola. That the applicant No.1 is mother, applicant No.2 is wife, applicant No.5 is married daughter and applicant nos.3, 4 and 6 are sons of deceased **Abdul Subhan Abdul Razzak**. It is submitted that the father of deceased **Abdul Subhan Abdul Razzak** namely Abdul Razzak Abdul Gafoor has died prior to the death of deceased. Therefore, the applicants are the legal heirs of deceased **Abdul Subhan Abdul Razzak**. They have in need of heirship certificate, hence they have filed this application.

3) In pursuance of the application, general citation at **Exh.No.06** as well as paper publication is issued. None were objected for the same, after publication of notice in the daily news paper 'Akola Darshan' dated **12.02.2026** at **Exh.No.10**.

4) The applicant No.3. Abdul Irfan Abdul Subhan lead evidence by way of affidavit at **Exh.No.11**. The applicants have filed documents along with list of documents **Exh.No.04** i.e. verified copy of death certificate of deceased **Abdul Subhan Abdul Razzak**, at **Exh.No.14**, and verified copies of Aadhar Cards of applicants at

**Exh.No.15 to 20.** The applicants have filed evidence closed Pursis at **Exh.No.12.**

5) After publication of the notice in the daily newspaper, Akola Darshan, nobody raised objection about the same, then no question arises to disbelieve the testimony of applicants. This means applicants are the legal heirs of the deceased. Therefore, the applicants are the legal heirs of deceased **Abdul Subhan Abdul Razzak**. Hence, I proceed to pass the following order :-

**ORDER**

1.	The application is allowed.
2.	Issue heir-ship certificate as per rule in the name of applicant No.1-Sabera Bi Abdul Razzak, No.2-Afsana Parveen Abdul Subhan, No.3-Abdul Irfan Abdul Subhan, No.4-Abdul Imran Abdul Subhan, No.5-Sihana Parveen Zakir Khan and No.6-Abdul Rizwan Abdul Subhan stating them as legal heirs of deceased <b>Abdul Subhan Abdul Razzak</b> r/o. Moulali Pura, Barshitakli, Tq. Barshitakli, Dist. Akola.
3.	The applicants are directed to furnish full and true inventory of all the property / credits received by them under this certificate within six months. A note to that effect be made in the certificate as per provisions contain in Chapter XIV Para 312 of the Civil Manual.
