ORDER BELOW EXH. 1
(Passed on 24.03.2026)

By way of this application, applicants seek issuance of legal heirship certificate under section 2 of the Bombay Regulation Act VIII, 1827.

2. It is contended by applicants that Rafikoddin Waziroddin died on 21/07/2023 at Kharpi, Tq. Chandur Bazar, Dist. Amravati. He was permanent resident of Kharpi, Tq. Chandur Bazar, Dist. Amravati. Applicant no.1 is widow, applicant nos. 2 & 3 are children of deceased Rafikoddin Waziroddin. Mother of deceased- Rafikoddin also passed away. Except applicants, there are no other legal heir left by the deceased. Applicants required heirship certificate of Rafikoddin Waziroddin for official work. Hence, they prayed that heirship certificate be granted to them.

3. In response to the application, a citation notice was issued and paper notice was duly published in newspaper “**Batmipatra**” on 31.01.2026 for inviting objections if any. However, nobody appeared before the Court to raise the objection to the present application. The citation notice is at Exh. 6 and copy of newspaper is at Exh.14.

4. In support of the application, applicant no. 3 Najim Uddin Rafik Uddin filed evidence affidavit at Exh.9 and reiterated the contents of the main application. Applicants filed on record copy of death certificate of deceased-Rafikoddin Waziroddin at Exh.10. Along with that

applicants filed verified copies of their Aadhar card from Exh. 11 to 13 respectively. They closed their evidence vide pursis at Exh. 15.

5. Heard the Ld. advocate for applicants.

6. Perusal of documents on record shows that Rafikoddin Waziroddin died on 21/07/2023. The case of the applicants is supported by oral and documentary evidence. No one challenged the evidence of the applicants. Therefore, there is no ground to disbelieve the evidence. Hence, considering the death certificate and other documents annexed to the application, and considering the fact that in spite of the proclamation issued, no objections were raised by any person, I do not find any impediment in granting the heirship certificate in favour of applicants. In the result, I pass following order :

:: ORDER ::

1. The application is allowed.
2. Applicants No. 1. Mahurun Nisa Rafiqodin 2. Mohinuddin Rafiquddin and 3. Nazim Uddin Rafik Uddin, are formally recognized as heirs of deceased- Rafikoddin Waziroddin.
3. Issue heirship certificate in favour of applicants as per rules.
