5. Particulars of offence explained to the accused:

Firstly, on 08.02.2023 between 12:30 to 13:30 hours on the banks of drain situated at Old Shindwadi, Tah.- Teosa, District - Amravati, you the accused was found illegally manufacturing 90 liters hand made liquor, 1600 liters Moha Sadava and other equipment worth of Rs. 42,170/- and thereby committed an offence punishable under **Section 65 (b) of The Maharashtra Prohibition Act, 1949** and within my cognizance.

Secondly, on the above-mentioned time, date and place, you the accused was found using iron drum, aluminum pot and plastic can for manufacturing hand made liquor and thereby committed an offence punishable under **Section 65 (c) of The Maharashtra Prohibition Act, 1949** and within my cognizance.

Thirdly, on the above-mentioned time, date and place, you the accused was found in illegal possession of 90 liters hand made liquor, 1600 liters Moha Sadava and other equipment worth of Rs. 42,170/- and thereby committed an offence punishable under **Section 65 (d) of The Maharashtra Prohibition Act, 1949** and within my cognizance.

Fourthly, on the above-mentioned time, date and place, you the accused were found illegally selling 90 liters hand made liquor and thereby committed an offence punishable under **Section 65 (e) of The Maharashtra Prohibition Act, 1949** and within my cognizance.

Lastly, on the above-mentioned time, date and place, you the accused were found illegally using iron drum, aluminum pot and plastic can for manufacturing hand made liquor and thereby committed an offence punishable under **Section 65 (f) of The Maharashtra Prohibition Act, 1949** and within my cognizance.
