IN THE COURT JUDICIAL MAGISTRATE, FIRST CLASS, WARUD

CHARGE

I, **A. B. Katte**, Judicial Magistrate, First Class, Warud do hereby charge you,

- 1) **Gulab Barkaji Kuite**,
Age :- 53 Years, Occupation :- Agricultural,
 - 2) **Dilip Gulabrao Kuite**,
Age :- 25 Years, Occupation :- Labour,
 - 3) **Swapnil bhagwantrao Kurwade**,
Age :- 23 Years, Occupation :- Labour,
- All are R/o Jarud Part-2, Tq.- Warud,
Dist.- Amravati

as follows :

Firstly

That on 06/07/2017 at 07:00 hours at Jarud, Tq. Warud, Dist.- Amravati in furtherance of common intension you accused persons without order or permission of prescribed authority illegally killed Chital and thereby committed offence U/Sec.9 punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Secondly :-

On above mentioned date, time and place in furtherance of common intension you accused persons illegally hunted the wild animal Chital and found in possession of meat of Chital and thereby committed offence U/Sec. 39(1) punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Thirdly :-

On above mentioned date, time and place in furtherance of common intension you accused persons found in illegal possession of wild animal large Bengal Monitor Lizard and Quails and meat of Chital without making report to nearest Police Station or Authorised Officer within 48 hours from obtaining the possession and thereby committed offence U/Sec. 39(2) punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Fourthly :-

On above mentioned date, time and place in furtherance of common intension you accused persons found in illegal possession of wild animal large Bengal Monitor Lizard and Quails and meat of Chital without previous permission of writing of Authorised Officer and thereby committed offence U/Sec.39(3) punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Fifthly :-

On above mentioned date, time and place in furtherance of common intension you accused persons found in dealing with captive animals and meat without any valid license issued by Authorised Officer and thereby committed offence U/Sec.44 punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Sixthly:-

On above mentioned date, time and place in furtherance of common intension you accused persons found in control custody or possession of “Bengal Monitor Lizard and Quails and meat of Chital” without any valid license issued by Authorised Officer and thereby committed offence U/Sec.48 punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Seventhly:-

On above mentioned date, time and place in furtherance of common intension you accused persons illegally transported the “Bengal Monitor Lizard and Quails and meat of Chital” without any valid permission issued by Authorised Officer and thereby committed offence U/Sec.48(A) punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Eightly:-

On above mentioned date, time and place in furtherance of common intension you accused persons illegally purchased, received, acquired or transferred or kept for sale the “Bengal Monitor Lizard and Quails and meat of Chital” without obtaining the wild animal from Authorised dealer or Authorised persons and thereby committed offence U/Sec.49 punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Ninethly:-

On above mentioned date, time and place in furtherance of common intension you accused persons illegally deal the wild scheduled animal viz Bengal Monitor Lizard and Quails and meat of Chital and cook the meat for eating in a house and thereby committed offence U/Sec.49(B) punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

Tenthly:-

On above mentioned date, time and place in furtherance of common intension you accused persons failed to produce any license or permission and found in illegal possession of the wild scheduled animal

viz Bengal Monitor Lizard and Quails and meat of Chital and thereby committed offence U/Sec.50 punishable U/Sec.51 of Wild Life Protection Act and within my cognizance.

And I do hereby direct you to face the trial on the said charge.
