ORDER BELOW EXH.26
IN SESSIONS CASE NO.239 OF 2025

The State of Maharashtra
Vs.
Gajanan Janrao Khedkar & Ors.

1. Applicant/accused No.1 Gajanan Janrao Khedkar has filed this bail application under Section 483 of Bharatiya Nagarik Suraksha Sanhita for regular bail in Crime No. 28 of 2016 registered at Daryapur Police Station for the offences punishable under section 307 R/w 34 of the Indian Penal Code.
2. Applicant/accused is facing trial before this Court for the offences punishable under Section 307 R/w 34 of the Indian Penal Code. Applicant No.1 was not attending the Court regularly, therefore, the then Additional Sessions Court issued non-bailable warrant against him. Non-bailable warrant was executed upon the accused on 17.07.2025 he was produced before the then Additional Sessions Court and was taken in Judicial Custody. Therefore, applicant approached to this Court and prayed to release him on bail.
3. It is contention of the applicant is that, he is only the bread earner of his family. His family depends upon him. Hence, he prayed that he be released on bail.

4. By filing say on the overleaf, Ld. P.P. resisted the application and strongly raised objection to grant this application.

5. Heard Ld. Advocate Shri. A.R. Gomashe for the applicant and Ld. P.P. Shri. S.D. Ghodeswar for the State.

6. Record shows that applicant is taken in Judicial Custody on 17.07.2025 and since then he is behind the bar. It is submitted by the Ld.Advocate for the applicant that the applicant is ready to attend the Court regularly and ready to conduct the matter. He further submitted that the applicant is ready to abide conditions if imposed by this Court. The applicant is ready to proceed with the case, therefore, no purpose would be served by keeping the applicant behind the bar. Apprehension raised by the non-applicant can be taken care by imposing conditions upon the applicant. In the circumstances, I am of the opinion that the applicant is entitled for bail by imposing certain conditions. Hence, the following order.

:: O R D E R ::

- 1) The application for regular bail is hereby allowed.
- 2) Applicant/accused No.1 Gajanan Janrao Khedkar be released on bail in Sessions Case No.239/2025 for the offences punishable under Section 307 R/w 34 of the Indian Penal Code on his executing personal bond of Rs.50,000/- (Rs. Fifty thousand only) with S.B. in the like amount, on the following conditions:
 - i) The applicant shall attend the Court regularly and shall proceed with the matter.

- ii) The applicant shall submit his authentic identity proof and authentic address proof.
- iii) The applicant shall furnish his recent mobile phone number.
- iv) The applicant shall furnish names, addresses and mobile phone numbers of his two near and dear close relatives.

3) Bail before this Court.
