Pooja Daraya Bhosle Vs. State of Maharashtra

ORDER BELOW EXH.01

By this application, the applicant has prayed for release of Honda Companies Motorcycle, bearing registration No. MH-20-EP-6236, Chassis No.ME4JC654CH7051346, Engine No.JC65E71072784 and mobile i.e. Redmi A2 + 4/128 AQUA BLUE mobile bearing IMEI No.86907606385518, seized by Gangapur Police Station, in connection with C.R. No. 63/2026 for offence punishable under section 503(A) and 331(3) of the Bhartiya Nayaya Sanhita, 2023. (Hereinafter referred as seized properties).

02. Perused the application, say of Ld. A.P.P., I.O. Also perused the documents of the vehicle and other documents on the record.

03. Heard the Ld. Advocate for the applicant and the Ld. A.P.P. for the State.

04. I.O. and learned APP filed their say. I.O. submitted that he has no objection to release vehicle on terms and condition. Whereas, learned APP for State submitted that, if seized mobile and vehicle is released applicant may commit similar kinds of offences and may change the nature of properties. Hence, prayed to reject the application.

05. Having gone through the application and the say filed by Investigating Officer it appears that, I.O. has seized the above-mentioned properties. In order to substantiate the contention made in the application, the applicant has filed on record verified copy of certificate of registration, Aadhar Card, mobile tax invoice, FIR and etc. on record,

06. The documents referred above indicates that, applicant is the owner of the seized properties. She is entitled for the possession of the seized property. No one has claimed the alleged properties except the applicant. Therefore, I do not find any reason to reject the present application. Hence, I pass following order -

ORDER

1. A) The Muddemal property i.e. Honda Companies Motorcycle bearing registration No. MH-20-EP-6236, Chassis No.ME4JC654CH7051346, Engine No.JC65E71072784, seized by Gangapur Police Station, in connection with C.R. No. 63/2026 for offence punishable under section 503(A) and 331(3) of the Bhartiya Nayaya Sanhita, 2023 be returned to the applicant on indemnity bond of Rs.50,000/- (Rupees Fifty Thousands Only).
- B) The Muddemal property i.e. Redmi A2 + 4/128 AQUA BLUE mobile bearing IMEI No.86907606385518 seized by Gangapur Police in connection with C.R.No. 63/2026 for offence punishable under Section 503(A) and 331(3) of the Bhartiya Nayaya Sanhita, 2023 be returned to the applicant Gaurav Machhindra Borude on indemnity bond of Rs.10,000/- (Rupees Ten Thousand Only).

2. Applicant shall give an undertaking that she shall not dispose off, alienate, create third party interest or change the nature of properties till the final disposal of case.
3. Applicant shall also undertake that she shall produce the seized vehicle and mobile in the Court, as and when required.
4. Applicant is directed to produce the photograph of said properties.
5. The Investigating Officer is directed to carry out detailed panchanama of seized properties before handing over the possession.
6. The copy of this application and order be kept with the criminal case arising out of C.R.No.63/2026, Gangapur Police Station.
7. Issue letter accordingly.
