**ORDER BELOW EXH. 1**

Present application is filed under section 503 of BNSS to release money of Rs. 7,046/- kept on hold in Cyber Complaint Acknowledgment No.319092501788 by Cyber Police Station, Chhatrapati Sambhajanagar Gramin.

02. Briefly it is contention of applicant that, his Account No. 80034545304 of Maharashtra Gramin Bank , Branch Lasur Station was hacked and for applicant lodged the FIR towards concern Cyber Police. The amount of Rs.16266/- is reduced from the account of applicant through total four times. On 29/08/2025, 28/08/2025,26/08/2025 the amount of Rs. 4200/- , Rs.66/- Rs. 6000/- + 6000/- (On same day I.e on 26/08/2025 ) is reduced respectively on given dates. Applicant had withdrawn Rs. 10,000/- through ATM card and Cyber Police holds remaining amount of Rs. 7,046/- of applicant is on hold.

03. Concern Bank conveyed the message to the applicant that due to his Cyber compliant said amount of Rs. 7,046/- is on hold and it may be get released only after order of Court.

04. Perused the say of concerned Police Inspector Cyber Police Station, Chhatrapati Sambhajanagar Gramin. He shown no objection to release seized amount of Rs. 7,046/- in favor of applicant.

05. Also perused the Ld. APP of Smt. V. P. Sadgure. Taken a objection to release the amount of Rs. 7,046/- .

06. I also gone through the track report filed by applicant where

--which shows that amount of Rs. 17,046/- through four times deduction from the account of applicant. As above matter is come under Cyber Police Station, Chhatrapati Sambhajnagar Gramin and inadvertent act of applicant is on record and supported by the I.O. and Ld. APP along with the documents.

07. Applicant is ready to undertake conditions imposed this Court. Therefore, applicant is entitled for the release of amount of Rs.7,046/- kept on hold by police as per the say of IO. Hence following order:

**ORDER**

1.	Application is allowed
2.	An amount of Rs.7,046/- kept hold by police be released and interim custody of the same be handed over to the present applicant in his bank account No. 0000080034545304 held at Maharashtra gramini bank, Branch Lasur Station subject to indemnity bond of same amount.
3.	The applicant to undertake that he will deposit the amount in court as and when so directed.
4.	The investigation officer is directed charge-sheet in this crime. to prepare detail panchnama regarding release of said money and tag along-with
