**: ORDER BELOW EXH. 01 IN CRI. M. A. NO. 79/2026:
(Ansh Infratech Pvt. Ltd. Vs. State of Maharashtra)**

1. The applicant has moved this application under Section 503 of BNSS to release the Tata Motors Trailer bearing registration No. MH-40-CD-8247, Engine No.B67B6A 250D02122C64202220 and Chassis No.MAT828022 N2C06366 which was seized from accused during investigation in the crime No.37/2026 by Police Station, Bidkin.

2. The learned A. P. P. and Investigating Officer have filed their say. The applicant has produced original scanned copy of R.C. book, copy of F.I.R., Scanned copy of Insurance, Scanned copy of PUC certificate, Scanned copy of authority letter, verified scanned copy of Aadhar Card of applicant. The RC Book shows that the Ansh Infratech Pvt. Ltd. is the lawful owner of such vehicle. On perusal of scanned copy of authority letter it reveals that Ansh Infratech Pvt. Ltd. has given authority letter to Lakhan Giri which shows he is empowered to file an application for release of said vehicle. Considering the nature of property, it is not necessary to detain the said property till the disposal of the trial. Hence, the applicant is entitled to the interim possession thereof till the conclusion of trial in Crime No.37/2026. It would be therefore just and proper to release the seized property in

the instant case to the applicant by imposing necessary conditions. Hence, I pass the following order :

: ORDER :

1. The application is allowed.
2. The seized property Tata Motors Trailer bearing registration No. MH-40-CD-8247, Engine No.B67B6A 250D02122C64202220 and Chassis No.MAT82802 2N2C06366 be released to the applicant on executing indemnity bond in an amount of Rs.20,00,000/-(Rs. Twenty Lacs Only).
3. The applicant is directed not to sell, alienate, transfer or dispose of the said vehicle till the disposal of trial in Crime No.37/2026 and to produce the same as and when required as per the order of this Court. The concerned officer to take photographs of the said property and to sign the same and obtain signature of the applicant.
4. Similarly, he has to prepare a detailed panchanama regarding the said property by obtaining the signature of the applicant and signing the same prior to its release.
5. The concerned officer to submit the above said photographs and panchanama to the court along with charge-sheet in the crime No. 37/2026.
