**Order below Exh.1**

This is an application for releasing Honda Unicorn two wheeler motorcycle bearing registration No. MH-20-HP-1340, Chasis No. ME4KC407MSA128257, Engine No. KC40EA4128325 seized in Crime No.37/2026, offence punishable under Section 65(a)(e) of Maharashtra Prohibition Act registered with State Excise Department, Aurangabad. (here-in-after referred as 'seized vehicle').

2. Perused the application and say of the learned APP, say of I.O. and documents filed on record. The application is supported by verified copy of Adhar Card, verified copy of RC Book, copy of Insurance and photo copy of FIR. On perusal of the documents, it appears that, the above said vehicle is standing in the name of applicant.

3. From documents i.e. copy of RC book of seized vehicle, it appears that it is standing in the name of applicant being it's owner.

4. Therefore, no purpose will be served by keeping the vehicle in the Police station. As the applicant has shown his ownership over the seized vehicle, he is entitled for the possession of the same. In result, the following order. :-

**ORDER**

- 1 Application is allowed.
- 2 The seized Honda Unicorn two wheeler motorcycle bearing registration No. MH-20-HP-1340, Chasis No. ME4KC407MSA128257, Engine No.KC40EA4128325 seized in Crime No.37/2026, offence punishable under Section 65(a)(e) of Maharashtra Prohibition Act registered with State Excise Department, Aurangabad be handed over to the applicant being registered

owner of the vehicle till the conclusion of the trial to applicant on his executing indemnity bond of Rs.1,50,000/- (Rs. One Lak Fifty thousand only).

- 3 The applicant to undertake that he shall not sale or transfer the said vehicle without prior permission of the Court. The applicant to maintain and preserve the said vehicle in all respect.
- 4 The applicant shall produce the said vehicle in the Court as and when directed by the Court.
- 5 The applicant to furnish two colour photographs of said vehicle with I.O.
- 6 The I.O. is directed to prepare detail panchanama of handing over of vehicle to the applicant and shall filed it along with charge-sheet arising out of above crime.
