



## JUDGMENT

The accused is present before me. He voluntarily pleaded guilty to the offences alleged against him. I accept the plea of the accused being voluntary one.

Considering the fine prescribed for the offence committed by the accused and having regard to the nature of the offence admission of guilt and the circumstances of the present case, I pass the following order.

## ORDER

- 1) The accused is convicted under Section 66(I) r/w. Sec.192 of Motor Vehicle Act of Motor Vehicle Act and sentenced to pay a fine Rs.500/- each (Rs.Five hundred only each) and in default accused to suffer simple imprisonment of two days.
