Exam-in-Chief by Ld. DGP Shri V. B. Bhole for the State :-

1] Since June 2016 to August 2021 I was attached to the ACB as PI. On 23/05/2017 Mohhamad Sabbir Mohhamad Hanif Sheikh filed written complaint against Mahesh Pathak. Two tenders were issued in the name of the son of the complainant from the Forest Department. One was a 15 X 20 platform at Virsi Fata in Nursery. The second was a platform a 15 X 20 near the Karanjekar school Javik Vividhata Udyan, Sakoli. Each worth Rs. 49,500/- together he received Rs. 99,000/-. This work was done by the complainant, his son and his friend Anil Wakekar together. The complainant was with the financial aspect of this work. This work was completed about one month ago. Cheque was received by one of accused. The second cheque was pending. The complainant inquired about it with Mahesh Pathak. He demanded bribe of 20% from the amount. Hence, the complainant gave written complainant to us. I am shown the written complaint it bears the signature of the complainant. Letter was issued to the Land Revenue Officer and The District Land Revenue Officer for providing panch. The letters are now shown to me. It bears the signature of the PI. Pradip Pullarwar. I identify the signature of him. The letters bear the signature of the clerk of the concerned office for receipt. Contents are true and correct. They are at

Exh. 106 and 107 respectively. The panch alongwith the letters from the concerned office were sent to our office. Now I am shown that letter at Exh.60. I am now shown the other letter receipt along the second panch. It was addressed to me. It is marked **Exh.108**. The panch was given the information about the complaint and their consent letter to act as panch was obtained. Now I am shown that consent letter at Exh.61. I know the letter. Now I am shown consent letter of panch Nilesh Khobragade. It bears my signature as before me. It is marked **Exh.109**. Then I introduced the complainant, panchas and the trap party. The complaint was given to the panch for reading it. They read it. Both the panch signed it. I also signed it. The complaint is at Exh.50.

2. The voice recorder which was going to be used for the trap was played before the complainant and the panch to demonstrate how it is give. A 8 GB memory card of Sandix company was inserted and got verified from the complainant and the panch with regards of the previous file existing in it. Instructions about pre-trap was issued to the complainant and panch No.1 Yogeshwar Dandare. The panch No.2 Nilesh Khobragade was instructed to remain with the trap party and observe. It was decided that the pre-trap verification would be done by going the Godhara bye pass.

Further examination-in-chief is differed by court time is over.
