ORDER BELOW EXH.41

This is the application for regular bail by applicant/accused No.3 Sandipan Balasaheb Dahiphale as per the provisions of Section 483 of B.N.S.S. who is in jail in execution of N.B.W.

02. Perused the application.

03. Present application is strongly opposed by learned A.P.P. by filing say on application itself.

04. Heard both sides at length.

05. Present accused was on bail during pendency of matter, but later on as he remained absent continuously, N.B.W. was issued against him and he is taken in M.C.R. Thereafter, this application is preferred by him for releasing him on fresh bail.

06. Matter is pending since year 2023 only because of continuous absentee of the said accused but now he is in jail for considerable long period and he must have understood the consequences of remaining absent. Therefore, just to give one more chance, he needs to be released on fresh bail. Therefore, following order.

ORDER

1] The bail application Exh.41 is allowed as under :

2] **Accused No.3 Sandipan Balasaheb Dahiphale** who is in jail in connection with Sessions Case No.162/2023, Crime No.651/2017 registered with Police Station Shivajinagar, Tq. and Dist. Beed for the offences punishable under section 341, 143, 147, 148, 504, 506 of I.P.C. and Section 135 of Maharashtra Police Act be released on execution of fresh P.R. Bond and one surety of Rs.10,000/- (Rs. Ten Thousand only) on following conditions :

- i) Accused shall give details of his permanent and present address along with documentary proof i.e. Aadhar Card.
 - ii) Accused shall give his mobile number and mobile number of his family members.
 - iii) Accused shall hence forth attend the Court regularly at 11.00 a.m. sharp on each and every date without giving any excuses.
 - iv) Accused shall not leave boundary of Beed District without prior written permission of this Court.
- 3] Inform the concern police station accordingly.
 - 4] Inform the accused through Superintendent of Jail Authority, Beed by sending soft copy of this order.
 - 5] Bail before this Court.
 - 6] Application is disposed off.
