**SESSIONS COURT AT BEED.****Criminal M.A. No. 159/2025****Komal W/o. Vikram Waghmare****Vs.****Ranjeet So Kanubhau Soloanke & another****ORDER BELOW EXH.1**

The applicant has filed transfer petition under Section 408 of Cr.P.C. r.w. Sec. 448 o Bhartiya Nagarik Suraksha Sanhtia 2023, for transfer of Sessions Case No. 112/2023 and Spl. Case No.1 5/2023 to one Court at Kaij for disposal.

2. Heard Ld. counsel Shri. U.D. More for applicant. Perused the material on record.

3. Upon considering the hearing, it is evident that, applicant filed complaint with Police Station Sirsala against Pravin Solanke and others regarding incident dt. 12/09/2017 which took place at 10.30 to 11.45 a.m. in village Mohkhed and accordingly Crime No. 187/2017 is registered and after completing investigation, I.O filed charge-sheet before Hon'ble Sessions Court at Kaij which bears Special Case No. 15/2023. It also reveals that, respondent No.1 filed complaint against present applicant and others with P.S. Sirsala in respect of incident dt. 12/09/2017 which took place at 10/30 hours at village Mohkhed and accordingly Crime No. 188/2017 u/sec. 394, 352, 506 of

IPC registered with P.S. Sirsala and after completing investigation charge-sheet is filed bearing Sessions Case No. 112 of 2023 and pending before Hon'ble Ad-hoc District Judge-1 & Addl. Sessions Judge, Kaij, Dist. Beed. In both cases incident happened on same date i.e. on 2/09/2017 at same time and same place. The witnesses in case are accused in other case and also vice versa.

4. Thus, both cases being counter and for convenience to lead evidence to the parties and to avoid conflicting decision in the matter, in the opinion of Court both matters can be tried together as per law and accordingly, I allow the application and pass the following order;

ORDER

- 1] Application is allowed.
- 2] Special (Atrocity) Case No. 15/2023 pending before Ld. District Judge-1 & Addl. Sessions Judge, at Kaij, Dist. Beed, is hereby withdrawn and made over to the Court of Ld. Ad-hoc District Judge-1 & Addl. Sessions Judge, at Kaij, Dist. Beed for disposal according to law alongwith Sessions Case No. 112/2023 .
- 3] Supdt (Judicial Branch) to give effect to the order.
- 4] Accordingly application is disposed off.
