(CNR No. MHBI0100-3986-2025)**The State of Maharashtra****Vs.****Karan Janu Alias Dhanu Shingare****ORDER BELOW EXH.07**

1] This is second application filed by the applicant/accused to release him on bail in Crime No.242/2025 (Special Case 240/2025) registered by Pimpalner Police Station.

2] There is allegations that complainant lodged report his daughter victim was kidnapped by this applicant/accused and taken to Shirdi and thereafter Madhya Pradesh and he committed the sexual intercourse on her and she was 17 years 11 months old at the time of incident. Applicant submitted that he has not committed such type of offences. In the statement under section 183 of the BNSS, before the Court victim has narrated that there was no forcible sexual intercourse committed by the accused. He is innocent. There is consensual relationship between victim and accused. Victim is attending the majority. There is no criminal antecedents. Custodial interrogation is not required. Due to family dispute he is falsely implicated in this case. He is ready to furnish surety. He is ready to abide all the conditions, if imposed by the Court. Therefore, prayed to grant bail.

3] APP has filed say and submitted that the said offence is related with the POCSO Act. The offence is heinous, antisocial and against minor child. There is prima facie case against the applicant. There is active participation of this applicant. If accused is released on bail, he again commit such type of offence and threatened to the victim. Therefore, prayed to reject the application.

4] Complainant has filed say at Exh.12 and submitted that accused has kidnapped her minor daughter and committed sexual intercourse on her. He submitted that if application is allowed, then there will be wrong message gone in the society. Accused will be abscond. He again commit such type of offence. He is threatening to the complainant. Therefore, prayed to reject the application.

5] Heard the Ld. advocate for the applicant and Ld. APP for the State and Ld. Advocate for the complainant.

6] I have gone through the record then it is found that victim is 17 years 11 months old. Statement of victim is also recorded under section 183 of BNSS. In the said statement she narrated that there was no forcible sexual intercourse committed by the accused. They married with the consent of victim. Considering the age of the victim, considering the nature of offence, no doubt the victim is at the verge of majority. She has knowledge regarding consequences of sexual intercourse. Considering the nature of offence, nothing is required to be seized from this accused. Already the clothes of the victim and

accused is recovered. All the investigation is completed. Charge-sheet is filed therefore, bail can be granted by imposing the terms and conditions. Hence, following order.

ORDER

- 1] Applicant/accused **Karan Janu Alias Dhanu Shingare** in crime No.242/2025 (Special Case No. 240/2025), registered with police station Pimpalner, Dist. Beed, for the offences punishable under sections 137(2), 64(1), 64(2)(I), 64(2)(F), 64(2)(M) of the Bharatiya Nyaya Sanhita, 2023 and Sections 4, 5(N), 6, 9(N), 10 of the Protection of Children From Sexual Offences Act be released on bail on furnishing bail bonds in the sum of Rs.50,000/- (Fifty Thousand Rupees only) with one or two sureties in the like amount.
- 2] The applicant shall report to the investigating officer as and when required.
- 3] The applicant shall not contact the victim.
- 4] The applicant shall not tamper with the evidence or attempt to influence or contact the complainant, witnesses or any person concerned with the case in any manner.
- 4] The applicant shall keep the Investigating Officer informed of his current address and mobile contact numbers, and/or change of residence or mobile details, if any, from time to time.
- 5] Bail before concerned Court.
- 6] The application stands disposed of.
