

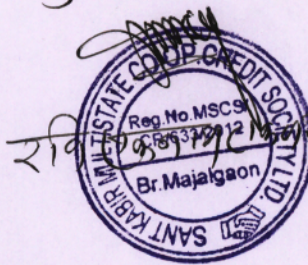

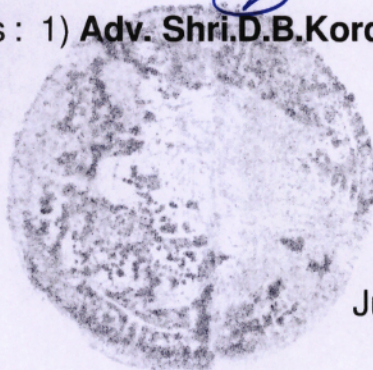

ORDER


1. This case is disposed of as withdraw pursis at **Exh.. 6**


