1. The present application is filed by the Plaintiffs praying for compliance of the directions passed by Hon'ble District Court in Civil M.A. No.310/2009. Whereby another suit pending between the parties, bearing RCS no.72/2008, was withdrawn from the then 2nd Jt. CJJD Georai and was transferred to this court for deciding the same, in accordance with law.
2. The defendant filed his say and submitted that, appropriate orders in view of aforesaid directions be passed.
3. Heard Id. Adv. Shri. P.B. Yewale for Plaintiffs and Ld. Adv. Shri. L.E. Lagad for the Defendants. Perused the entire material placed on record. The Hon'ble Principal District Judge in Civil. M. A. No. 310/2009 was pleased to allow the application and prayer of the Plaintiffs for transfer of sister case to this court, was allowed. Perusal of record reveal that, the said order was not placed along with the proceedings of

the present suit. Therefore, the directions of the Hon'ble Principal District Judge, Beed could not be complied. The Plaintiffs have placed on record certified copy of the order passed in Civil. M. A. No. 310/2009. Perusal of the order would reveal that, the Hon'ble Principal District Judge was pleased to transfer RCS No.72/2008 to this court. It was further directed that the transferee court shall immediately transfer the record to this court. Needless to say, that the directions are binding and remained to be complied with. Therefore, the application of the Plaintiffs deserves to be allowed. Accordingly, the following order is passed: -

ORDER

- 1) Application is hereby allowed.
- 2) The record of RCS No. 72/2008 pending before Hon'ble 3rd Jt. C.J.J.D., Georai be called, in view of order passed by Hon'ble Principal District Judge, Beed in Civil M. A. No. 310/2009.
- 3) Issue request letter accordingly.
- 4) The A.S. is directed to update the record on CIS accordingly.
