ORDER BELOW EXH-1

1. This is an application seeking interim custody of Renault India Pvt. Ltd., company bearing registration No. MH-23-AS-6013 having and Chesis No. MEEBBA008HC556785 and Engine No. BDA404E101424 moved under section 503 of B.N.S.S. which was seized in crime No. 77/2026 registered at police station Georai for the offence punishable u/s 177, 134 of MV Act and section 125(a), 125(b), 106(1), 281 of BNS 2023. According to the applicant, he is the registered owner of the above said vehicle which is seized in above mentioned crime number. He requires the said vehicle for his use. Hence, he prayed to allow this application.

2. By filling say Ld. A.P.P. opposed the application and contending that, offence is of serious in nature. If said vehicle returned to applicant then applicant might change its nature or sell it. Hence he sought for rejection of this application. I.O. has no objection to release the seized vehicle at appropriate condition.

3. Perused the record. It appears that, the applicant has filed on record the verified copy of R.C. Book. Further, applicant has filed copy of insurance of the vehicle. Therefore, it appears that, applicant is the owner and vehicle is insured. Vehicle seized is remained idle in the premises of the police station. If it is kept as it is then it may junk and became useless. Therefore, in my view the vehicle seized is required to be released in favour of applicant. Therefore, I proceed to pass following order.

ORDER

1.	Police Station Officer, Georai is hereby directed to hand over interim custody of Renault India Pvt. Ltd., company bearing registration No. MH-23-AS-6013 having and Chesis No. MEEBBA008HC556785 and Engine No. BDA404E101424 seized by it in Crime No. 77/2026 to the applicant Santosh Shahadeo Munde , R/o- Shahu Nagar, Beed, Tq. Dist. Beed, after R.T.O verification if required on due verification of his I.D proof and on his executing indemnity bond of Rs. 5,00,000/- (Rupees Five Lakhs Only) on condition that he shall not sell, pledge or encumber the vehicle, and shall produce the same as and when required during the course of investigation or trial, as the case may be.
2.	I.O. is directed to take two colour photographs of vehicle before handing over on Supurtnama on the expenses of the applicant and file it in the case.
3.	Issue Supurutnama accordingly.
