Examination in chief of prosecution witness no. 10 by Ld. APP Smt.

S. A. Gaikwad -

01. I was serving as MO at Sub District Hospital Georai on 20.01.2023. Since 2004, I am serving as a Medical Officer. I had treated one Bhagawat Asaram Madne on 20.01.2023. I was told history of physical assault. I examine him and gave him necessary treatment. I found following injuries over his person

A. Contusion over occipital region ad. measuring 1 X 0.5cm, possibly caused by some hard and blunt object. It was injury caused within 24 hrs. It was simple injury.

B. Contusion over right elbow admeasuring 1 X 0.5 cm possibly caused by hard and blunt object. It was injury caused within 24 hrs. It was simple injury.

02. Occipital region is located on back head. I had taken necessary entries in MLC register maintained at Sub District Hospital Georai. I had taken his left thumb impression over MLC register. I have issued MLC certificate of said patient. The witness is now confronted with MLC certificate bearing sr. no.486. It is the same which I issued. It bears my signature and seal. The contents are true and correct as per my knowledge. Hence, the document is exhibited as **Exh.25**. The injury at Sr. no.01 can be caused by means of a stone. Injury at Sr.

no.01 and 02 can be caused by means of a stone and wooden stick.

Examination in chief is over.

Cross Examination Adv. I. B. Nagare on behalf of Accused -

03. On 20.01.2023, I was on duty since 09.00 am in the morning till 09.00 am on 21.01.2023. It took 15 to 20 minutes to treat him. It is true to say that, injury in the nature of Sr. no.1 & 2, is possible if a person suddenly fall on rough surface. It is not true to say that, I have never treated patient Bhagawat Asaram Madne on said day. It is not true to say that, I am deposing false on oath. Such injuries are possibly caused before 2 hrs, before I treated him. It is not true to say that, contents in examination in chief are false.
