JUDGMENT
(Delivered on 12/03/2026)

1. The accused has submitted that, he is ready to plead guilty. Upon inquiry, I found that the guilt so confessed by the accused is without any compulsion, force or inducement. I have also informed the accused that in case he pleads guilty of the offence, he might be subjected to punishment as prescribed by law and therefore, he should not be under an impression that only because of his such confession, the Court would think of awarding him lesser or lenient punishment. Even then the accused assert that he is voluntarily pleading guilty.

2. Being convinced of the voluntary nature of plea of guilt of the accused, I accept the same.

3. Having regard to the nature of crime committed by the accused and having heard the accused and prosecution, I am of the opinion that following sentence shall serve the ends of justice. Hence, the order:

ORDER

- 1] The accused namely Shafik Babu Sayyed is hereby convicted for the offence punishable u/s.12(a) of the Maharashtra Prevention of Gambling Act vide Section 252 of the Code of Criminal Procedure, 1973 and sentenced to under go imprisonment till rising of Court and to pay fine of Rs.300/- (Rs. Three Hundred only), in default of payment of fine, the accused shall undergo S.I. for 1 (One) day.
- 2] Seized Muddemal i.e. Rs.920/- be credited to the Government after appeal period is over. Remaining muddemal pen, chit book be destroyed after appeal period is over.
