**ORDER BELOW EXH.1 IN REGULAR
CRIMINAL CASE NO.48/2026**

(State of Maharashtra Vs. Shankar @ Aaryan
& Ors.)

1. Accused No.1 Shankar @ Aaryan Madhukar Shep is in jail, thus, he is present through video-conferencing from jail. Accused 3. Ujwal @ Dada Mahadev Munde and 4. Sanket @ Ganesh Suresh Gangatre are present before the Court. So far as accused No.2 Kalyan Wachistha Shep is concerned, after filing of charge-sheet he became absconded. He failed to appear before Court after order of proclamation and attachment against him. Thus, charge-sheet against him is committed against him under Section 335 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Dharur Police Station has filed this charge-sheet against accused for the offences punishable under Sections 109, 115(2) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023. Section 109 of the Bharatiya Nyaya Sanhita, 2023 is triable by the Court of Sessions. Hence, it is necessary to commit the case to the Hon'ble Sessions Court, Kaij, Dist.Beed. The copies of police report and other documents as specified in Section 230 of Bharatiya Nagarik Suraksha Sanhita have been supplied to the accused Nos.3 and 4 and as per request of accused No.1 sent to him through Superintendent, District Prison, Beed.

2. Perused pursis at Exhibit 13 and 14 filed by the Ld.Advocates for accused Nos.3 and 4 contending that, accused Nos.3 and 4 will appear and positively remain present before the Hon'ble Sessions Court, Kaij on **15.06.2026** without fail. On V.C. accused No.1 also has been notified about this next date. Under such circumstances, the present proceedings will have to be

committed to the Court of Sessions. Hence, the order.

ORDER

1. The case is committed to the Court of Sessions, Kaij as per Section 232 of Bharatiya Nagarik Suraksha Sanhita.
2. Accused No.1 Shankar @ Aaryan Madhukar Shep, 3. Ujwal @ Dada Mahadev Munde and 4. Sanket @ Ganesh Suresh Gangatre are directed to appear before the Court of Sessions, Kaij on **15.06.2026**.
3. The copies of police report and other documents as specified in Section 230 of Bharatiya Nagarik Suraksha Sanhita be sent to accused No.1 through Superintendent, District Prison, Beed.
4. The record of the case, documents and the articles which are produced in the evidence shall be send to the Court of Sessions, Kaij.
5. The police station officer of concerned Police Station is directed to produce the muddemal property in the Court of Sessions, Kaij on or before **15.06.2026** positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Court of Sessions, Kaij.
