

ORDER BELOW EXH.1 IN CRI.M.A. NO.517/2022

The complainant has filed private complaint against the accused person under section 420,467,468, 471, 323,504,506, read with 34 of Indian Penal Code. Perused the complaint, affidavit, verification and documents annexed with the complaint, it appears that accused person are residing at a place beyond the area in which exercises his jurisdiction. Therefore the inquiry under section 202 of the Code of Criminal Procedure is mandatory in order to the sufficient ground for proceeding. Considering the allegation made in complaint, the complainant has not produced the documentary proof in respect of allegations. The complainant is produced the xerox copies of mobile screenshots. It is not sufficient material to proceed with matter. The complainant has made allegation in respect of commission of offence relating to the documents. It must required to satisfied ingredients of offence. Considering the provision of the section 202 of the Code of Criminal Procedure, this court postponed the issue process against the accused person. It would be proper that to make inquiry by concern police officer for the purpose of deciding whether or not there is sufficient ground for proceedings. Hence I passed following order.

ORDER

1. The police inspector of Rural Police Station, Parli V. is directed to make inquiry in the present matter as per section 202 of the Code Of Criminal Procedure and forward report to this court within 2 month.
