Chief-examination on behalf of prosecution by Ld. APP Shri. V. M. Darunkar-

1. I have received witness summons. I have done my M.B.B.S. in 2019. Since 15/09/2021 I am working as a medical officer at Kada Rural Hospital. Till today I have examined around 100 medico legal cases. Today I have brought with me original MLC register and police memo.

2. On 03.12.2023, I was present in the hospital. On that day at around 08:40 a.m. injured/ informant Rupali Madane, Tushar Madane and Balasaheb Madane had came to me along with police memo. Original police memo and carbon copy of police memo on reccord **Exh. 58** is true and same. Patinet Rupali stated history of physical assault on 3/12/2023 in the morning. She had black mole on right side of neck. I examined her and found following injuries.

1. CLW on right cheek below eye - size 1 x 0.5 x 1 cm.
2. Blunt trauma on right parietal and occipital region of head.
3. blunt trauma on back.

All injuries were within 6 hours, caused by hard and blunt object. Nature of injuries were simple. Patient then referred to R.H. Ashti for X-ray of skull and CT brain. No report received till today.

3. Patient Tushar Madane-19 yrs stated history of physical assault by known person on 3/12/2023 at morning. He had black mole on left shoulder. I examined him and found following injuries.

1. CLW on right side of forehead - size 1.5 x 1 cm.
2. blunt trauma on anterior lower region of right forearm.
3. blunt trauma on parietal and front region of head.

All injuries were within 6 hours, caused by hard and blunt object. Nature of injuries were simple.

4. Patient Balasaheb Madane-50 yrs stated history of physical assault by known person on 3/12/2023 at morning. He had old injury mark on right ankle. I examined him and found following injuries.

1. blunt trauma on back.
2. blunt trauma on front and parietal region of head.

All injuries were within 6 hours, caused by hard and blunt object. Nature of injuries were simple.

5. I have brought original MLC register with me. All injuries which are mention in MLC No. 43 to 45 are as per original MLC register. The medico legal certificates are now shown to me. It bears my signature. The contents of it are

true and I recorded it after psychically verifying the injured. The said M.L.C. is given **Ex. 69 to 71/ PW5**.

6. MLC were handed over to police on 17/01/2024 upon their request letter dated 15/01/2024. Said letter shown to me which bears signature of my office staff which I identify. Contents of letter are true and correct. Letter given as **Exh.72**. Injuries mentioned in MLC Exh. 69 to 71 are possible if person hit by stone approximately 500 grams. I can identify person examined if shown to me.

7. If any patient without police memo came to us we used to refer such case to police. Police memo Exh. 58 given for two person namely Rupali Madane and Balasaheb Madane. It is true to say that, there is no police memo given for patient namely Tushar Madane. We generally ask patient about time of assault, and time is stated as per the say of concern patient. While taking history, we used to ask about weapon used for assault, if stated by patient, then we write it accordingly. It is true to say that, size of injuries are depend upon size of weapon used. It is true to say that, injuries mentioned on MLC Exh. 69 to 71 are possible if person falls of the motorcycle.

8. PHC Kada do not have X-ray facility. Ashti PHC has said facility. It is true to say that, exact time of assault can not be stated in blault trama cases, however approximate range

can be stated. Generally single patient takes around 15 min. for examination and single patient is treated at a time. It is not true to say that, I have given false MLC and I have deposed falsly.
