A. It is therefore the Hon'ble court may kindly be allowed the application.

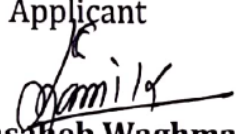

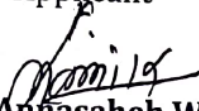
