ORDER BELOW EXH.15

(Passed on this 11th day of March 2026)

1] This is an application under Section 503 of Bharatiya Nagarik Suraksha Sanhita, 2023 filed by applicant for releasing Motorcycle Hero Splendor Pro bearing registration No. MH-30-AK-7511, Engine No. DHM32455, Chasis No.DHM02317 on supratnama.

2] According to applicant/accused, Police Station Raipur seized above said Motorcycle in Crime No.169/2025. He is owner of seized motorcycle. Now, said Motorcycle is lying in the premises of police station Raipur in idle condition. Applicant is in need of said Motorcycle for his day to day routine work. Further, if Motorcycle remained in idle condition then it will be rusted and ruined. Hence, applicant prayed to release the seized motorcycle on supratnama.

3] Learned APP Smt.Saoji-Deshpande has filed say through Investigating Officer vide Exh.20 and strongly opposed the

application. She submitted that if Motorcycle is released on supratnama, applicant may change its nature. Lastly, prayed to reject the application.

4] Heard both the sides. Perused documents filed on record. Verified copy of R.C. Book show that, seized motorcycle belongs to applicant. At present seized Motorcycle is lying in the premises of police station. Trial will take its own time to conclude. Under such circumstances, in case the seized Motorcycle is kept lying in the premises of police station in idle condition, then it will be rusted and ruined. Purpose of producing the Motorcycle before Court as and when required can be secured by imposing certain conditions, while releasing the seized Motorcycle on supratnama.. Hence, I pass the following order;

ORDER

- 1] Application is allowed.
- 2] Seized Motorcycle Hero Splendor Pro bearing registration No. MH-30-AK-7511, Engine No. DHM32455, Chasis No. DHM02317 in Crime No.169/2025 registered at Police Station, Raipur be released on supratnama on executing supratnama Bond of Rs.1,00,000/- by the applicant.
- 3] Police Station Officer, Raipur is directed to obtain four side photo-graphs of seized Motorcycle and prepared panchanama regarding giving interim custody of seized Motorcycle and submit it to the Court.
- 4] Applicant shall not sale out, transfer or shall not create any third party interest or charge on the seized Motorcycle, so also, shall not change the nature and appearance of seized Motorcycle in any manner, till final disposal of the case.

- 5] Applicant shall produce seized Motorcycle as and when asked to do so.
- 6] Inform the order to Regional Transport Officer, Buldhana, accordingly.
- 7] Supratnama be executed before this Court.
