C H A R G E

I, A.G. Santani, Addl. Sessions Judge, at Buldhana, hereby charge you:

1. Ganesh Janardan Wayal,
Aged : 44 Years, Occupation : Agriculturist,
2. Rameshwar Janardan Wayal,
Aged : 36 Years, Occupation : Agriculturist,
3. Raju Bhaskar Wayal,
Aged : 21 Years, Occupation : Agriculturist,
All Residing at Padali Shinde, Tq. Deulgaon Raja,
District Buldhana.

as follows :-

01. Firstly, that on 12.11.2022, at 09.15 p.m., at Padali Shinde, you all, in furtherance of your common intention, voluntarily caused hurt to the informant namely Raju Govinda Shelke by means of an iron rod and stick, which if used as a weapon of offence is likely to cause death, and thereby, you committed an offence punishable U/s. 324 r/w. 34 of the Indian Penal Code, 1860, and within my cognizance.
02. Secondly, at the same time, you all, in furtherance of your common intention, voluntarily caused hurt to the informant by means of fist blows and slapping, and thereby, committed an offence punishable U/s. 323 r/w. 34 of the Indian Penal Code, 1860, and within my cognizance.
03. Thirdly, at the same time, you, in furtherance of common intention, intentionally insulted the informant and thereby, gave provocation to him intending or knowing it to be likely that such a provocation will cause him to break the public peace or to commit any other offence and thereby, you all committed an offence punishable U/s. 504 r/w. 34 of the Indian Penal Code, 1860, and within my cognizance.
04. Lastly, at the same time, you, in furtherance of common intention, committed criminal intimidation by threatening to the informant with dire

results and thereby, committed an offence punishable U/s. 506 r/w. 34 of the Indian Penal Code, 1860, and within my cognizance.

And, I hereby direct that you be tried by this Court on the aforesaid charges.
