SEPARATE ORDER UNDER AWARD

(Passed on this 14th day of March 2026)

The claimant and his learned Counsel Shri S.J.Deshmukh are present. The opponent No.3 Insurance Company has given authority letter [Exh.27] in favour of Advocate Shri B.B.Pande to settle the matter. Under terms of joint pursis [Exh.24] compromise has been arrived at amongst the parties. In view of the compromise terms, matter has been settled at an amount of Rs.25,000/- to be paid by opponent No.3 to the claimant towards full and final settlement of the claim inclusive of N.F.L. amount, interest and costs. Opponent No.3 to deposit the amount within a period of 45 days from the date of receipt of the order. Hence, the following order.

ORDER

- 1] Claim is disposed off against opponent No.3 in terms of joint pursis [Exh.24].
- 2] Opponent No.3 Insurance Company is directed to deposit the amount of **Rs. 25,000/- (Rs. Twenty Five Thousand Only)** so as to pay it to the claimant towards full and final settlement of the claim inclusive of N.F.L. amount, medical bills, interest and costs.

- 3] The compensation amount be paid to the claimant as notified below-

Claimant	Apportionment	Manner of investment and payment
Claimant	Rs.25,000/-	The entire amount be paid to him by directly crediting it in his bank account by e-payment mode.

- 4] The opponent No.3 shall deposit aforesaid amount of compensation along with interest thereon, if any, in the following Official Bank Account of the Member, Motor Accident Claims Tribunal, Buldhana by e-payment mode;

- 5] Opponent No.3 shall deposit the amount as aforesaid within a period of 45 days from date of receipt of the order. Failing which, the claimants are entitled to receive the aforesaid amount with an interest of 6% per annum from the date of order.

- 6] **The claim to proceed further against opponent Nos. 1 and 2.**
- 7] The refund of court fees, if any, be made as per the rules prevalent.
- 8] Award be drawn up accordingly.
