ORDER BELOW EXH.1

(Passed on this 15th day of December 2025)

1] This is an application preferred by the applicant under Section 503 of the Bharatiya Nagarik Suraksha Sanhita for releasing Mobile of Realme P1 5G (8+128) [IMEI No.866287078610215] company on supratnama.

2] Perused the application and say filed by the Investigation Officer below Exh.5 through learned APP Smt.Saoji-Deshpande.

3] Heard learned advocate for applicant as well as learned Addl.Public Prosecutor.

4] The applicant is praying for return of above said Mobile on supratnama. Being owner of the said vehicle, it is submitted by applicant that, she is the registered owner of said Mobile and the said Mobile was seized from accused by the Police Authorities in connection with Crime No.923/2025, Under Sections 8(c), 20(b) of the N.D.PS.Act, 1985 registered with Buldana City Police Station. The investigation in respect of the said Mobile is completed and therefore, for no reason the Mobile is lying with the Police Station and requested to release the above said Mobile on supratnama.

5] The prosecution has opposed the application on the ground that, the said Mobile was used in commission of crime and if the said Mobile is released on supratnama, the applicant may commit similar type of offence again in future by using said Mobile. There is every possibility that, the applicant may tamper or dispose of the said Mobile and requested to reject the application.

6] It is submitted by the applicant that, he is registered owner of the said Mobile, which came to be seized by Buldana City Police in Crime No.923/2025. The copy of purchase receipt of said Mobile supports this say of applicant. The Investigation Officer is having objection to return the said Mobile. The said Mobile is kept in concerned Police Station for considerable period. If the Mobile is not properly utilized, there is every possibility that, it will affect its utility and usefulness. The applicant is ready to abide by the

conditions imposed by Court. Hence, I pass the following order;

ORDER

- 1] The application below Exh.1 is hereby allowed.
- 2] The concerned Police Station is hereby directed to return the seized Mobile of Realme P1 5G (8+128) [IMEI No. 866287078610215] on supratnama to the applicant namely Savitri Babu Jadhav after obtaining photographs and recording the detailed panchanama of the said Mobile on following conditions;
 - i] The applicant shall execute the supratnama/indemnity bond of Rs.20,000/-with one surety of Rs.15,000/- on following conditions;
 - ii] The applicant shall not sale, transfer or dispose off the said Mobile, till the conclusion of trial.
 - iii] The applicant shall not change the nature of the Mobile.
 - iv] The applicant shall produce the said Mobile before the Investigation Officer or this Court as and when required for trial.
