C H A R G E

I, Shaikh Akbar Shaikh Jafar, Additional Sessions Judge, Buldhana, do hereby charge you :-

1. Amol Gulabrao Mahale,
Age 35 years, Occu- Labour,
2. Anil Gulabrao Mahale,
Age 26 years, Occu- Agri.
3. Ankush Rajaram Nikalje,
Age 40 years, Occu- Agri.
Aakash @ Sonu Ramesh Nikalje,
Age 20 years, Occu- Agri.
All R/o Soygaon
Tq. & Dist. Buldhana,

as follows :-

- 1) That, on 20-04-2025, at about 23-30 hours at village Soygaon Tq. & Dist. Buldana, you accused persons in furtherance of your common intention assaulted on the head of complainant Kautikrao Sahebrao Mahale, with such intention or knowledge, and under such circumstances, that if by that act you had caused the death of Kautikrao Sahebrao Mahale, you would have been guilty of murder and thereby, committed an offence punishable under Section **109(1) r/w. S.3(5)** of the Bharatiya Nyaya Sanhita, 2023, within my cognizance.

That on the above said date, time and place, you accused persons in furtherance of your common intention, voluntarily caused hurt to complainant Kautikrao Sahebrao Mahale with iron rod, which is used as a weapon of offence and thereby committed an offence punishable under Section **118(1) r/w. S.3(5)** of The Bharatiya Nyaya Sanhita, 2023, within my cognizance.

That on the above said date, time and place, you both the accused in furtherance of your common intention, intentionally insulted complainant Kautikrao Sahebrao Mahale, thereby gave provocation to him, intending or knowing it to be likely that, such provocation will cause him to break the public peace or to commit any other offence and thereby committed an offence punishable under Section **352 r/w. S.3(5)** of The Bharatiya Nyaya Sanhita, 2023, within my cognizance.

That, on the above said date, time and place you both accused in furtherance of your common intention, committed criminal intimidation upon complainant Kautikrao Sahebrao Mahale and thereby committed an offence punishable under Section **351 (2) r/w. S.3(5)** of the Bharatiya Nayaya Sanhita, 2023 and within my cognizance.

And I hereby direct that you be tried by the said Court on the aforesaid charges.
