CHARGE

I, **Shaikh Akbar Shaikh Jafar**, Special Judge, Buldana, hereby charge you :-

Sajid Shaha Sadik Shaha
Age- 28 years, Occu. Labour
R/o Sailani
Tq. & Dist. Buldhana

as follows;

1] That on 03-09-2022, at about 1-30 p.m. at Sailani Tq. & Dist. Buldhana, you accused kidnapped victim aged about 14 years, out of keeping of the lawful guardianship of parents without their consent and thereby committed an offence punishable under Section 363 of the Indian Penal Code, and within my cognizance.

2] That on the same date, time and place, you accused induced victim, a minor girl, with intent that in order that she may be forced or seduced to illicit intercourse and thereby committed an offence punishable under Section 366-A of the Indian Penal Code, and within my cognizance.

3] That, since from prior to six months of 08-10-2022 till 07-10-2022 at Sailani and in Chakan area, Pune, you accused repeatedly committed rape upon victim aged about 14 years and incapable of giving consent and thereby committed an offence punishable under Section 376 (2)(j)(n) of the Indian Penal Code, and within my cognizance.

4] That, since from prior to six months of 08-10-2022 till 07-10-2022 at Sailani and in Chakan area, Pune, you accused repeatedly committed rape upon victim aged about 14 years and thereby committed an offence punishable under Section 376 (3) of the Indian Penal Code, and within my cognizance.

5] That, during the above mentioned period and place you accused committed penetrative sexual assault upon minor victim and thereby committed an offence punishable under Section 4 of POCSO Act and within my cognizance.

6] That, during the above mentioned period and place you accused committed aggravated penetrative sexual assault upon minor victim and thereby committed an offence punishable under Section 6 of POCSO Act and within my cognizance.

7] That, during the above mentioned period and place you accused committed sexual assault upon minor victim and thereby committed an offence punishable under Section 8 of POCSO Act and within my cognizance.

8] That, during the above mentioned period and place you accused committed sexual harassment to the minor victim and thereby committed an offence punishable under Section 12 of POCSO Act and within my cognizance.

9] That during the above mentioned period and place, you accused not being the member of Scheduled Castes or Scheduled Tribes committed the offence the offence of rape against minor victim belongs to Scheduled Caste and thereby committed an offence punishable under Section 3(2)(v) of Scheduled Castes & Scheduled Tribes (Prevention of Atrocities) Act.

And, I hereby direct that you be tried by me on the above-said charges.
