**Exam.-in-chief by Shri J. K. Deshmukh, Advocate for claimants.**

1] I am M.B.B.S. M.D. (Medicine). I am running my own private hospital by name "Solanki Hospital And Critical Care Centre, Buldana".

2] On 05-02-2018, the patient namely Gajanan Pandurang Talekar was admitted in my hospital as an indoor patient with history of a road traffic accident. He was admitted as an indoor patient from 05.02.2018 to 07.02.2018. The patient had suffered a massive blood loss with hypotension and respiratory compromise. The patient went into cardiac arrest. On examination, I found that there was fracture of right lower limb bone femur and pubic ramus. The patient was kept on ventilatory support and referred to higher centre for further management. Now, the discharge card issued by me is shown to me. I identify the same. The contents are true and correct. It is marked as **Exh.84.**

3] Now, a certificate dated 09.02.2018 issued by me is shown to me. It bears my signature. The contents are true and correct. It is marked as **Exh.85.**

4] During the course of treatment I obtained X-ray

report, color doplar of right lower limb, ultrasound report of abdomen and pelvis and MRI of brain.

5] The hospital had raised bill of Rs.66900/- only. The patient had paid the said hospital bill of Rs.66900/- only. Now the hospital bill and receipt are shown to me. They bear my signature. The contents are true and correct. They are collectively marked as **Exh.86**.

6] As the patient was critical, I referred him to multispeciality hospital. During the treatment, as per my prescription the relatives of the patient brought the blood and plasma from Jivandhara Buldana Urban Blood Bank and blood transmission was done.

**Cross-exam. by Adv. Salim Shaikh for opponent No.1:-**

7] When called absent. Hence, no cross-examination.

**Cross-exam. by Adv. Pravin Suradkar for opponent No. 2:-**

8] After 07.02.2018, the patient did not approach me for the treatment. It is true that I had maintained the record of the patient. It is true that I have not brought the said record with me. It is not true to say that I am deposing false that the patient was admitted as an indoor patient from 05.02.2018 to 07.02.2018. It is not true to say that I am deposing false that I had treated him and obtained various report. It is not true to say that I have charged excess bill. It is not true to say that I am deposing false to help the applicants.
