**Order below Exh.1**  
(Passed on 13/3/2026)

1. The applicant (Original claimant No.3) namely Alfiya Parvin d/o Yusuf Khan has filed the present NRJE for permission to withdraw the amount as per judgment and award passed in the MACP No.35/2013, dated 29.12.2015. It is submitted by the Ld. Advocate for the applicant that the matter was decided on 29.12.2015 and the amount came on the share of applicant of Rs.62,121/- and it was deposited in fixed deposit at State Bank of India, Branch Nandura, in A/C No.36016337384 and its maturity period is till 03.9.2026. But now the applicant attains majority and her marriage date is fixed on 24.5.2026 with Shaikh Awez Shaikh Karim R/o. Wadgaon Hashampur, Tq. Jalgaon Jamod, Dist.Buldhana. Hence, she requires the said amount for her marriage. Therefore, she needs the pre mature withdrawal of the F.D. amount. Hence, the present applicant filed the application for getting the said amount of her share along with accrued interest on it.

2. Perused the judgment and order dated 29.12.2015 in MACP No.35/2013 and present application. As per judgment and order Rs.50,000/- + interest and cost were directed to be kept in fixed

deposit in the name of minor claimant No.3 till she attains the age of majority. Also perused the copy of School Leaving Certificate placed on record below Exh.3 and Marriage Invitation Card placed on record by the applicant below Exh.4. As per School Leaving Certificate, the date of birth of applicant/original claimant No.3 is 04.02.2004. It means she became major. As per say of Nazar, amount of Rs.62,121/- vide Certificate dated 03.9.2016 is kept in fixed deposit for ten years i.e. till 03.9.2026. As the applicant is in need of money for her marriage and she became major, therefore, she is permitted to withdraw the amount Rs.62,121/- kept in fixed deposit in her name along with further interest amount. Hence, application deserves to be allowed. In result, I pass following order :-

**ORDER**

- 1) Application is allowed as prayed.
- 2) Nazar (C&F) is directed to issue letter to State Bank of India Branch Nandura, Tq.Nandura, Dist.Buldhana, for breaking open the FDR of A/C No. 36016337384 to disburse the amount kept in that Bank as per order dated 29-12-2015 in MACP No.35/2013 after due verification and identification of the applicant through advocate.
