This is an application filed by the applicant Deep Ramesh Agrawal permission to file the document on record.

2. Non-applicant through Advocate Shri. S.V. Agrawal has filed say below the application and resisted the application.

3. Ld. Advocate Mr. B.K. Gandhi for the applicant has submitted that the document which the applicant is going to be produced is necessary for proper adjudication of the matter. Hence, he urged to allow the production of document.

4. On the other hand, Ld. Advocate Mr. S.V. Agrawal for the non-applicant has submitted that no ground is made out in the application for production of document concern in appeal. He further submitted that, there is no explanation given by the applicant as to why the said

The record shows that applicant/original non-applicant No. 3 in case No. ARB/KUCB/M/34/2010 of Khamgaon main branch being aggrieved and dissatisfied with the award dated 21/09/2012, passed by the arbitrator has challenged it, as per Section 34 of the Arbitration and Conciliation Act by filing the main application.

7. In this proceeding, applicant is seeking to produce on record the copy of search report. Though the non-applicants have resisted the application, but, the applicant has specifically mentioned that said document is necessary to decide the main application. Considering the nature of the matter, I am of the opinion that, the document which the applicant is seeking to produce is necessary for proper adjudication of the matter. Therefore, if the
