Order below Exh.37

(Passed on 4.5.2023)

1. This application is preferred for releasing the applicant/accused on parole.
2. Heard learned advocate Mr.G.H.Ingle for applicant/accused and learned A.P.P. Mr.S.B.Ingle for the prosecution. Perused the say of prosecution overleaf the application. Gone through the case diary.
3. It is submitted on behalf of the applicant/accused that applicant/accused is permanent resident of Gaurpura, Rupsing Tanda, Tq.Indravali, Dist. Adilabad, Telangana, but his father-in-law namely Narsing Lalsing Sable resides at Chinchkhed Nath, Tq. Motala, Dist. Buldhana. He is innocent and not committed any type of offences as alleged. The applicant/accused is the sole main in his family to look after the marriage of his sister. The marriage of his sister is fixed on 13th May 2023, the invitation card to that effect is filed on record. Hence prayed for allowing the application.

4. It is submitted on behalf of the prosecution overleaf the application that the offence charged is under NDPS Act is very serious in nature and if the applicant/accused is released on bail, then the chances of he fleeing away. Therefore, prayed for rejecting the application.

5. Perused the case record, it is seen that the applicant/accused is charged under NDPS Act and there is prime facie involvement of the applicant/accused in the present crime, and it would not be proper to release the applicant/accused on bail. However, considering the facts that the marriage of sister of applicant/accused is fixed therefore, only for purpose of attending marriage applicant/accused Atmaram Gopalsing Sable is released on temporary bail. Hence the following order :-

ORDER

- 1] The application Exh.37 is hereby allowed.
- 2] The applicant/accused No.2 Atmaram Gopalsing Sable, R/o. Gaurapura, Rupsing Tanda, Tq. Indravali, Dist. Adilabad, State Telanga, is hereby released on temporary bail on conditions mentioned below on his executing PR bond of Rs.15,000/- (Rs. Fifteen Thousand only) with one local surety in the like amount along with cash sure of Rs.10,000/- (Rs. Ten thousand only) to attend the marriage function of his sister from 10.5.2023 till 20.5.2023.
- 3] The applicant/accused is directed to surrender himself before concerned Jail Authority on 20.5.2023 itself.

Conditions

- [i] Applicant/accused shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the accusation against him so as to dissuade the witness from disclosing such facts to the Court or to any Police Officer and not to pressurize any prosecution witness.
- [ii] Applicant/accused shall provide his permanent address proof, copy of Adhar Card and photographs.
- [iii] Applicant/accused should not involve himself in commission of alike offences.
- [iv] The surety is directed to furnish copy of his Adhar Card, Pan Card, Bank passbook till tomorrow and also furnish the list of names, other details and address of his family members.
- [v] Applicant/accused has to surrender before Jail Authority on 20.5.2023 in the morning without fail.
- [vi] Failure to obey any of the conditions above, would be liable for cancellation of bail granted to applicant/accused.
