**Judgment**

(Delivered on 27/03/2026)

This is an application filed under section VIII(2) of the Bombay Regulation Act, 1827 for issuing legal heirship certificate.

2. It is submitted that the applicant No.1 is the widow of deceased Ulhas Sheshrao Deshmukh and applicant No.2 to 4 are the son and daughters of deceased Ulhas Sheshrao Deshmukh. Deceased Ulhas Sheshrao Deshmukh died on 05/03/2006 at Shegaon, Tq. Shegaon, Dist. Buldana. So also father of deceased Ulhas Sheshrao Deshmukh namely Sheshrao Gulabrao Deshmukh died on 28/04/2004 at Shegaon, Tq. Shegaon, Dist. Buldana. So also mother of deceased Ulhas Sheshrao Deshmukh namely Gayabai Sheshrao Deshmukh died on 18/03/1997 at Shegaon, Tq. Shegaon, Dist. Buldana. Applicants are the legal heirs of deceased Ulhas Sheshrao Deshmukh. Applicants need legal heirship certificate for Government and semi Government purpose. Hence, applicants filed the present application.

3. Following points arose for my consideration for the determination of this case and my findings thereon with reason to follow.

**: REASON :**

**As to point No.1 and 2 :**

4. The applicant No.2 has led his evidence by way of evidence affidavit (Exh.11) in support of their claim. Original copy of death certificate (Exh.12 to 14) of deceased Sheshrao Gulabrao Deshmukh, Gayabai Sheshrao Deshmukh and Ulhas Sheshrao Deshmukh disclosed that they are dead. Heirship certificate (Exh.15) issued by Corporator, Ashish Gangane of Municipal Council, Shegaon also show that applicants are the

only legal heirs of deceased Ulhas Sheshrao Deshmukh.

5. The proclamation (Exh.20) was published in daily news paper Lokopchar dated 13.01.2026 inviting objection within 30 days but none has appeared and raised objection until now. Notice inviting objection was also affixed on the notice board of Civil & Criminal Court, Shegaon, Nagar Parishad Shegaon and notice was also affixed on the house of the applicants. Needless to say that, the issuance of heirship certificate does not confer any right on any person in respect of property of deceased. The issuance of heirship certificate in the name of applicants is the formal recognition of the applicants as legal heirs of the deceased Ulhas Sheshrao Deshmukh and the applicants have established their said claim. Considering the documentary and oral evidence on record, I am satisfied that applicants are heirs of deceased Ulhas Sheshrao Deshmukh. Therefore, it is just and desirable to issue legal heirship certificate in favour of applicants. Hence, I answer the point No.1 and 2 in affirmative and in answer to point No.3, I proceed to pass following order.

### **ORDER**

1. The application is allowed.
2. It is hereby declared that applicants are legal heirs of deceased Ulhas Sheshrao Deshmukh. Legal heirship certificate be issued in the name of applicant No.1 Chhaya Ullasrao Deshmukh, applicant No.2 Govind Ulhasrao Deshmukh, applicant No.3 Jyoti Amol Deshmukh and applicant No.4 Ujwala Manoj Mahalle, as they are the only legal heir of deceased Ulhas Sheshrao Deshmukh on payment of requisite court fees.
