**Application for grant of legal heirship certificate under Bombay
Regulation Act VIII of 1827**

J U D G M E N T

(Delivered on 05th day of May, 2026)

1. This application is filed for grant of heirship certificate under the provisions of Bombay Regulation Act VIII of 1827.

The case of the applicants in brief are as follows:-

2. Applicant No.1 to 3 are the children, No.4 is the daughter in law and No.5 to 7 are the grandchildren of deceased **Mahadeorao Yadoji Pimpalkar** and deceased **Gayabai Mahadeo Pimpalkar**. Hence, in this way Applicants are the legal heirs of deceased **Mahadeorao Yadoji Pimpalkar** who died on 09.06.2013 and deceased **Gayabai**

Mahadeo Pimpalkar who died on 09.01.2016. The applicants are in need of legal heir certificate. Hence, this application.

3. In support of their contention the applicant No.5 Ramesh Bramhadeo Pimpalkar has examined himself by filing his affidavit at **Exh.13**. He re-iterated the contents of application. He deposed as per application and relied upon verified copy of death certificates of deceased **Mahadeorao Yadoji Pimpalkar** at **Exh.14**, deceased **Gayabai Mahadeo Pimpalkar** at **Exh.15**, deceased **Bramhadeo Mahadeorao Pimpalkar** at **Exh.16**. Certificate issued by Corporator, Municipal Council, Shegaon, Tq.Shegaon at **Exh.17**. Verified photocopies of Aadhar cards at **Exh.18 to 24**. respectively. Paper bill and Paper publication in newspaper "Lokopchar" dated 12.03.2026 at **Exh.25 & 26** respectively. Evidence closed pursis at **Exh.27**.

4. The above documents shows that applicants are legal heirs of deceased **Mahadeorao Yadoji Pimpalkar** and deceased **Gayabai Mahadeo Pimpalkar**. The public notice was issued in above newspaper on 12.03.2026 at **Exh.26**. However none appeared and contested the case. The testimony of applicants and documents referred above corroborates contents of petition. The documentary evidence support oral testimony of applicant. No objection has been received to the public notice issued in above newspaper. Thus, it appears that applicants are the legal heirs of deceased and they are entitled for legal heirship certificate, hence the application deserves to be allowed. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue legal heirship certificate in the name of applicants namely Anandrao Mahadevrao Pimpalkar, Kausalya Janardan Wankhade, Panchfula Vasanta Umbarkar, Rukhmabai Bramhadeo Pimpalkar, Ramesh Bramhadeo Pimpalkar, Suresh Bramhadeo Pimpalkar, Ujwala Raju Vathurkar, declaring them as the recognized legal heirs of deceased '**Mahadeorao Yadoji Pimpalkar** and deceased **Gayabai Mahadeo Pimpalkar**' as provided under the provisions of Bombay Regulation Act VIII of 1827 on payment of requisite Court fees.
3. This certificate is not valid for mutation of any movable or immovable property.
