ORDER BELOW EXH.1

Perused the record. Case is 25 years old. Perused warrant against accused Shrikrushna Kashiram Manjare, R/o Kapasi Tq. Patur, District Akola. It appears from the record that accused did not appeared before the court till date. As accused is hiding himself from the warrant, it is necessary to issue proclamation under section 82 of Code of Criminal Procedure against the accused. The accused must be aware of the proceeding and warrant and in spite of it he failed to appear. Hence issue proclamation under section 82 of the Code of Criminal Procedure Code against the said accused only in proforma as per schedule -II, proforma No.4 Police are to be directed to search and submit necessary particulars of movable and immovable properties belonging to accused, to enable the Court to proceed as per **section 83 of Cr.P.C.** Hence, I pass following order ;

OPERATIVE ORDER

- i) Issue proclamation under ***section 82 of Cr.P.C.*** against accused.
- ii) Police Station Officer of police station concern is directed as per ***section 82 (2) (I) s(a) Cr.P.C.*** to publicly read the proclamation in some conspicuous place of the town or village in which accused ordinarily resides, and as per ***section 82 (2) (I) (b) Cr.P.C.*** to affixed the proclamation to some conspicuous part of the house or

homestead in which accused ordinarily resides or to some conspicuous place of his town or village.

- iii)** Police Station Officer of police station concern is also directed to prepare a detailed panchanama regarding compliance of execution of this proclamation and submit the same in the Court.
- iv)** Police Station Officer of police station concern is also directed to collect the necessary particulars of movable and immovable properties belonging to accused and submit it in the Court alongwith the report.
- v)** Assistant Superintendent of the Court is also directed to affix the copy of proclamation to the conspicuous part of the Court house or notice board of the Court, as per **section 82(2)(i)(c) of Cr.P.C.**, and submit report accordingly.
- vi)** Copy of this order be sent to the Police Inspector of Police Station concern for its efficient and expedite compliance.
